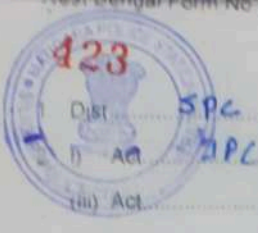


Respected Sir,
