Sir,

I, SI Kalyan Saha of Pradhan Nagar PS, SPC do hereby lodge this complaint to the effect that today on 30.01.2023 at about 13.05 hrs. I received specific source input that one vehicle has been coming from Sikkim side with huge amount of illicit liquor loaded inside one Bolero having number plate bearing No WB 704 D 4292 for its disposal in different state of Bihar clandestinely. Accordingly, I diarized the fact in Pradhan Nagar PS General Diary Book vide GDE NQ 1924- Dated 30.01.2023 and consequently passed the information to you for kind instruction. Subsequently, as per your direction myself along with PSI Bijay Sarkar, C/880 Shymal Dutta, C/762 Mujibul Rahaman, CV/646 Baban Das and CV/242 Rakesh Mangar, all of Pradhan Nagar PS, SPC left Pradhan Nagar PS to verify the veracity of the information.

At 13.25 hrs. we reached at the Darjeeling More Road under PS- Pradhan Nagar and started checking vehicles. After sometimes being pointed by my source I found one white colored Bolero having Reg No. WB-72 D-4292 was coming towards Darjeeling More side. On sighting police, the driver and the other persons try to fled away from the spot but we managed to chased them and detain 04(Four) person namely Mukesh Kumar (32) s/o Shyam Sundar Sah of Nowhatta PO+PS Nowhatta Dist Saharsa Bihar 2)Pappu Sadah (35) s/o Bilas Sadah of Jhakra PO Bahadurpur PS Alauli Dist Khagaria Bihar 3)Sanjib Kumar Paswan (35) s/o Siaram Paswan of Barasher Kumbra Ghat PO-Barasher PS Bihira Dist Saharsa Bihar 4)Sunil Sah (26) s/o Boyelaal Sah Of Dualak PO Modhepur PS Bheja Dist Madhubani Bihar (Not Verified)

Then I searched the vehicle and could recovered the following quantity of sealed foreign liquor bottles of different brands which was loaded in secret modified chamber of said vehicle:

- 1) 70 (Seventy) pieces sealed Royal Castle Blue premium whisky, each bottle containing 750 ml, MFD - 10.01.2023, blended and bottled by Mount Distilleries Limited, Mazitar, Rangpo, Sikkim. RS 254/-each (Total 52.500 Liters)
- 2) 216 (Two hundred sixteen) pieces sealed Royal Castle Blue premium whisky, each bottle containing 375 ml, MFD - 16.01.2023 each blended and bottled by Mount Distilleries Limited, Mazitar, Rangpo, Sikkim. RS 128/- each (Total 81.00 Liters)
- 3) One white colour bolero having number plate bearing No WB 74 D 4292.

The whole process of seizure was made in between 14.05 hrs to 15.10 hrs in presence of available witnesses namely 1) Gaffar Islam s/o Lt Md Masiruddin of Sukna Tea Estate PO Gulma PS Pradhannagar Dist Darjeeling and 2) Krishna Roy s/o Lt Dinesh Roy of Dagapur Kathalguri PS Pradhannagar Dist Darjeeling. They confessed that they are doing the same business since long for their wrong full gain and not only they ,many other person of different place is also involved in this racket.

Under the above circumstances, you are requested to kindly register a specific case under proper section of law against the driver namely Pappu Sadah (35) s/o Bilas Sadah of Jhakra PO Bahadurpur PS Alauli Dist Khagaria Bihar , other person namely 1) Mukesh Kumar (32) s/o Shyam Sundar Sah of Nowhatta PO+PS Nowhatta Dist Saharsa Bihar 2)Sanjib Kumar Paswan (35) s/o Siaram Paswan of Barasher Kumbra Ghat PO-Barasher PS Bihira Dist Saharsa Bihar and 3)Sunil Sah (26) s/o Boyelaal Sah Of Dualak PO Modhepur PS Bheja Dist Madhubani Bihar (Not Verified) and also registered owner of the vehicle and others and arrange for its investigation.
