I, SI Chetan Dangal of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted accused person to the effect that on 30.01.2023 at about 18.55 hrs. I received a specific source information that one person is coming from Sukna side towards Darjeeling More with huge quantity of Ganja. The matter was diarized in Pradhan Nagar PS GDE No.1942 Dt. 30.01.2023 and also informing the matter to you in written and as per your kind direction, myself along with S.I Kalyan Saha, A.S.I. Manoj Roy, ASI Biplab Das, C/762 Mazibul Rahman, CV/223 Swapan Chhetri, all of Pradhan Nagar Police Station left P.S for Dagapur, under PS- Pradhan Nagar by Govt. vehicle to verify the veracity of the information vide Pradhan Nagar PS GDE No. 1943 Dt. 30.01.2023, M.C.C. No. 279 Dt. 30.01.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. At the time of departure from Police Station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

On way to Dagapur, I contacted two persons namely (i) Krishna Roy s/o Late Dinesh Roy of Dagapur, KathalDangi, under Champasari GP, PS Pradhan Nagar, Dist Darjeeling (W.B) and (ii) Gaffar Islam s/o Late Md. Masiruddin of Sukna Tea Garden, P.O Gulma, PS Pradhan Nagar, Dist Darjeeling and made them aware of the information in hand and requested them to be the witnesses, if any search and seizure would be made and upon which they become willing as to be. Thereafter we along with the independent witnesses reached Dagapur at 19:15 hrs. after waiting for almost 04 (four) hours, I saw one motorcycle coming from Sukna Side heading towards Darjeeling more and as being pointed by my source we blocked the road and cordoned the area, after seeing us the bike rider tried to flee from the spot but somehow, we managed to apprehend him at Siliguri-Darjeeling Link Road opposite Dagapur Football Ground, under Pradhan Nagar P.S, Dist. Darjeeling jurisdiction with one motorcycle model no R15, Version 3.0 matt black, without any registration number loaded with two bags of said to be ganja at the rear back of the motorcycle.

Thereafter, we disclosed our identity and the information in hand. On being asked by me he disclosing his identity as noted above and admitted that the bags in his possession contains ganja which he wants sale to his designed customers at Nepal border. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazette Officer. Then he agreed to be searched in presence of any one of the above. On being asked he, searched only my person in presence of independent witness and found nothing except my personal belongings

Then, I informed the matter to you and as per your order, I informed Shri Gyaltsen Lepcha, Assistant Commissioner of Police, under Siliguri Police Commissionerate who has been detailed as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Ganja and requested him to come to the spot and to remain present and supervise the search and seizure. At 22.55 hrs Shri Gyaltsen Lepcha, ACP/SPC arrived at the spot and in presence of two independent witnesses search of the detained person has been conducted following all formalities keeping decency and recovered the above noted articles from the conscious and exclusive possession of accused Hitlar Roy. On being asked, in presence of Shri Gyaltsen Lepcha, ACP/SPC acting as Special Executive Magistrate, SPC the detained person namely Hitlar Roy failed to produce any valid document in support of possessing of the Ganjas. Thereafter, I weighted the recovered packets one by one separately with the weighing instrument which stands as motioned above and total of 25.717 Kg (twenty-five kilograms and seven hundred and seventeen grams) in total seven (09) packets which are wrapped with brown colour cello-tape and also extracted 100 grams ganja from each packet as sample for examination. Then, I seized the above noted articles at the spot under proper seizure list and also labelled and sealed the articles in presence of Shri Gyaltsen Lepcha, ACP/SPC and independent witnesses and also obtained signature of the above noted witnesses and the Special Executive Magistrate, SPC and put my signature too and also acknowledged by the accused person. The whole process of seizure was made in between 23.25 hrs to 23.55 hrs.

Being further asked the apprehend person admitted in presence of Shri Gyaltsen Lepcha, ACP/SPC and independent witnesses that he has procured the ganja clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he has been dealing in such business of procuring and selling of ganja illegally for last few years with his co-associate namely Sanju Biswakarma s/o Nandalal Biswakarma of Middle Palash, PS Pradhan Nagar, Dist. Darjeeling A/P DamakBaazar, PS Damak, Dist. Jhapa, Nepal and Subhas Sapkota @ Dukhi s/o Padam Bahadur Sapkota of Katar Dara under Singsare OP, PS Birtamod, Dist. Jhapa, Province I, Nepal.

from the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Hitlar Roy is involved in procuring and selling of Ganja illegally contravening the norms of NDPS Act. Thus, I arrested the above noted accused person namely Hitlar Roy after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Hitlar Roy (M-26) s/o Late Khitish Chandra Roy of Gandogal Jote, Panitanki Near Nepal Border, P.O Dulal Jote, under Khairibari P.S, Dist Darjeeling, West Bengal and others namely Sanju Biswakarma s/o Nandalal Biswakarma of Middle Palash, PS Pradhan Nagar, Dist. Darjeeling A/P Damak Baazar, PS Damak, Dist. Jhapa, Nepal and Subhas Sapkota @ Dukhi s/o Padam Bahadur Sapkota of Katar Dara under Singsare OP, PS Birtamod, Dist. Jhapa, Province I, Nepal and arrange for its investigation.
