I, Smt. Neelam Singh, Wife of Sanjeev Singh, resident of Naya Busty, P.O., P.S. and Dist.-Darjeeling, would like to lodge this complaint against Smt. Mala Chhetri, Daughter of Karan Bahadur Chhetri, Wife of Sri Bharat Chhetri and Sri Arjun Chhetri, Son of Karan Bahadur Chhetri, both are residents of Khaprail Bazar, P.O.- New Chamta, P.S.- Matigara, Dist.- Darjeeling.

Sir, in the year 2017, I have purchased one land measuring 3 Kathas more or less 4.95 Decimal, recorded in L.R. Khatian No.- 3041, Under L.R. Plot No.- 397, situated at Mouza- Khopalashi, within P.S.- Matigara, Dist.- Darjeeling, from said Mala Chhteri and his brother viz. Arjun Chhetri.

Sir, presently I have intended to sell my aforesaid land, then I have firstly found that though said Mala Chhetri and Arjun Chhetri have given me the registry of the aforesaid land in L.R. Plot No.- 397, but knowingly they have given me possession in another plot number illegally.

Sir, on measuring the land, the Amin have pointed out me that I am in possession of my aforesaid purchased land in L.R. Plot No.- 433, which said Mala Chhetri and Arjun Chhetri have shown and affirm me as L.R. Plot No.- 397.
