With due respect, I beg to report that I SI Srimanta Chaterjee of Bhaktinagar Police Station ,SPC hereby lodge this complaint against the above noted ten accd. Persons ,to the effect that, on 12.02.23 at about 21:55 hrs on duty table officer ASI Tanmoy Roy informed me that a chaos is going on at Nesha Bar, Sevok Road in between two groups and they creating nuisance using objectionable words & showing their violent attitude in public who were present there at in front of COSMOS Mall. I informed about the information to I/C Bhaktinagar PS and as per his direction, I along with my officer and forces namely SI Rantu Halder ,PSI Koushik Raha C/986 Rajib Sarkar , C/915 C. P. Adhikary, CVF/ 614 Sumit Kr.Roy ,CVF/ 935 Biplab Roy all of Bhaktinagar PS had been to the spot at Nesha Bar, Sevok Road under this PS. After reaching there found that some persons shouting there using slang languages to each other in front of Nesha Bar . When we tried to enter into Nesha Bar some Bouncer of Nesha Bar stopped us but somehow we entered and tried to pacify them but the above noted ten persons turned deaf ear and suddenly the above noted accused persons became violent and push me and used slang languages but somehow I managed to dodge the hit. They also assaulted us with fist and blows and also assaulted us by sharp cutting weapon with a view to murder. Seeing this incident, while the accused persons found beyond their control then I called to our van officers SI D. N. Bakshi ,SI Sabin Yanjon Tamang who also patrolling nearby Sevok Road area, came with force all are Bhaktinagar PS/SPC and retrieved us from the trouble. But One of them caught hold shirt tightly of SI D. N. Bakshi . However, I able to arrest the above noted ten accused persons namely u/s- 41 Cr.P.C after observing all rules and formalities. They also damaged few traffic burials and a Govt. Vehicle bearing Registration no- WB-77 5658 , After that we medically treated at Siliguri Sadar Hospital.
