Subject: FIR

Sir,

In producing herewith three (03) arrested accused persons namely (i) Bishal Roy (M/32), S/O- Lt. Sitaram Roy of Diesel Colony, PS Pradhan Nagar, Dist. Darjeeling (ii) Pritam Gurung (M/27), S/O- Lt. Gopal Gurung of Pratap Goan, PS Mirik, Dist. Darjeeling (iii) Rajib Sewa (M/42) s/o Mani Kumar Sewa of Church Road, PS Sadar, Gangtok, Sikkim (not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron rod measuring 33 inch (approx.) including butt from the possession of Bishal Roy which was kept concealed on his back side.
- (2) One iron made axe measuring 23 inches (approx.) including wooden butt from the possession of Pritam Gurung which was kept concealed on his back side.
- (3) One iron made axe measuring 23 inches (approx.) from the possession of Rajib Sewa which was kept concealed on his back side.
- (4) One iron made hammer measuring 10.5 inches (approx.) in length found from the place of occurrence.

I, SI Abhishek Theengh, S/O- Suchandra Kumar Theengh of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Bishal Roy (M/32), ii) Pritam Gurung (M/27) and iii) Rajib Sewa (M/42) and others to the effect that today on 14.02.2023 at 11.45 hrs. received a source information that 08/09 persons were assembled at Siliguri junction, below Pati Colony over bridge under Pradhan Nagar PS with a view to commit dacoity at adjoining areas of Pati Colony under Pradhan Nagar PS, SPC. The fact was diarized in GD vide Pradhan Nagar PS GDE No-778, dated 14.02.2023.

Subsequently, after sharing the information with my superiors myself along with ASI- Ashit Kumar Singh, CV/242 Rakesh Mangar, CV/992 Jagadish Biswas, CV/646 Baban Das left for the place to work out the information. At about 12.20 hrs. after reaching at Siliguri Junction below Pati Colony over bridge under PS- Pradhan Nagar, I met my source and being pointed by the source we started walking towards Siliguri junction, below Pati Colony over bridge under Pradhan Nagar PS and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them.

They tried to flee away but on a hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Pati Colony area. On search of each person, I could recover the articles from their possession and seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 12.55 hrs. to 01.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.


I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Pati Colony area. It is also revealed from them that Akash Tamang, Md. Kalu and some others have assembled there with them and planned for committing the dacoity.

Hence, I pray before you that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Bishal Roy (M/32), S/O- Lt. Sitaram Roy of Diesel Colony, PS Pradhan Nagar, Dist. Darjeeling (ii) Pritam Gurung (M/27), S/O- Lt. Gopal Gurung of Pratap Goan, PS Mirik, Dist. Darjeeling (iii) Rajib Sewa (M/42) s/o Mani Kumar Sewa of Church Road, PS Sadar, Gangtok, Sikkim (not verified) a vi) Akash Tamang, vii) Md. Kalu and others and others and arrange for its investigation.


