Sabir (4) ~~Hamida Khatun~~ (5) Fuljodi Khatun w/o Md. Nasim (6) Saiyida Khatun d/o Md. Sabir, all are Nepali Pally, Conl Depo, Ward No. 7 SMC, P.O-Siliguri Buzar, P.S-Siliguri, Distt.
