Dear Sir,

With due respect I Smt. Pratima Roy w/o Sri Prahlad Roy resident of Saratnagar - Shivmandir, Po. New Rangia, PS: Matigara Dist. Darjeeling, would like to inform you that on 14-02-2023 at about 11:30 AM to 12 Noon at nearby my house, my son Ajit Roy 15 years and about 5 yrs old Samrat Barman ^{were} playing, in the mean time Samrat Barman call his Mother, told that Ajit Roy beating him by fist, at that time Smt. Popi Barman w/o Chaitanya Barman came out from the house and started to beat my son by bamboo and caught hands of my son, quarrelled and gasted with filthy languages. At the same time Anindita Barman d/o Shyamal Barman came and started to beat my son by foot and fists and fell down at ground and hit by leg wearing shoes on head and chest as such my said son bled from mouth and sustained several pains and bodily internal injuries. At that time I was not present at home. On heard of hue and cry I came thereon, then said Popi Barman called Smt. Shila Barman and Shyamal Barman (Parents of the Anindita Barman). They came and suddenly started to quarrel me, my son by saying my son is 'Pagal' and physically assaulted me by tearing my hairs and dress, caught my neck to kill me at that moment Shyamal Barman squeezed by breast and forcefully trying to disrobing me and also snatched my Mangal Sutra with golden locket. On hue and cry neighbours came and rescue me from their hands. Thereafter I took my son for primary treatment then Doctor advice me to visit medical college for treatment. On 16-2-2023, 17-02-2023 I visit NBMCH for treatments of my said son. He has been advised several tests and medication. My said son is since 6 months earlier under treatment of a psychiatric Doctor Arunava Dutta, Siliguri. Due to such reason I unable to lodge complaint in due time of the said occurrence.

The above named culprits ① Smt. Popi Barman w/o Sri Chaitanya Barman ② Smt. Shila Barman w/o Shyamal Barman ③ Anindita Barman d/o Shyamal Barman and ④ Shyamal Barman s/o not known of same area demanded Rs. 5 Lacs when I called for 'compromise our dispute' as illegal demand of money from us. If not given Then They will do anything offences with us and threatened us with dire consequences.
