1. That on 23.02.2023 yesterday at about 11.30 P.M. I visited the place Near-St. Thomas School to sand falling on the ground Suddenly one Saikat Roy neak name (Ghutur Bhai @ Gutur) son of Unknown, residing at Gurung Basti, Ward No. III of S.M.C., Near- St. Thomas School, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling is threatened, physically assaulted and brutally attacked with fists and blows without any reason.

After that on that time my wife namely Smt. Sabita Das came to the incident and she tried to save me from his hands and then he also physically assaulted my wife.

- 2. That I got serious injury on my left Ear and whole body swelling.
- 3. That due to such assaulted upon me and my aforesaid wife and due to his such attempt to murder me in such cruel manners, I sustained severe injuries on my persons and I am medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 24.02.2023 at about 11.00 A.M. and still I am under medical treatment.
- 4. That due to serious injury caused due to such assaulted by him upon me and my aforesaid wife delay is caused for lodging this F.I.R. which may kindly be condoned.
