Respected Sir,

I, SMT. ANKITA KUNDU, wife of Sri Koushik Paul and Daughter of Sri Avijit Kundu resident of 2nd By Lane, Swamiji Sarani, Hakimpara, within ward No. 15 of Siliguri Municipal Corporation, Post Office & Police Station - Siliguri, District - Darjeeling, Pin - 734 001 in the state of West Bengal would like to inform you that I got married to Sri Koushik Paul, son of Sri Nitai paul permanent resident of Sanaka Niwas, 12, Bimal Sinha Sarani, Opposite Dada Bhai Hotel, within ward No. 12 of Siliguri Municipal Corporation, Post Office & Police Station - Siliguri, Pin - 734 001, District - Darjeeling in the state of West Bengal on 15.01.2021 under the provisions of Special Marriage Act, 1954 and subsequently, my social marriage took place on 19.01.2021 at Sky View Hotel, Opposite Uttar Banga Marwari Bhawan, Sevoke Road, Siliguri. That after the social marriage, as aforesaid, I was brought to my matrimonial house wherein I along-with my husband started our conjugal life. That at the time of my marriage my parents gave me various gold ornaments / jewelries, utensils, cloths and furniture's like King size bed, Godrej Steel almirah, dressing table etc., as my Stridhan properties. That it is pertinent to mention here that my parents have also given to my husband one gold chain, one Diamond Ring, wristlet, gold ring, wrist watch, cloths and also shoes etc., and also gave valuable gifts to my in-law and brother-in-law as per their demand. That the aforesaid articles except some gold ornaments are still remaining in the custody of my husband and in-laws. That soon after the marriage, my husband along-with my in-laws started mental torture upon me and, thereafter, I was taken to Kerala at the work place of my husband, my husband used to assault me on various occasions and, therefore, due to second wave of Covid and work from home my husband took me back to my matrimonial house at Siliguri. That during the stay at my matrimonial house, my in-laws never allowed me to come to my paternal house and during that period my in-laws inflicted mental torture upon me for bringing more dowry. That thereafter my parents and well wishers tried to negotiate the dispute with my husband and my in-laws, but all efforts went in vain. I thinking about my future thought and decided to stay at my matrimonial house providing them one more chance thinking that with the passage of time my husband and in-laws after realizing their fault will rectify themselves and then I shall be able to lead a happy conjugal life with my husband. Thereafter once again after few days the mental and physical tortures upon me by my husband and my in-laws were started and ultimately finding no other alternatives I once again informed the same to my parents and on 26.02.2023 i.e., today my uncle Sri Arjit Dutta Joardar, Advocate and my aunty Smt. Soma Dutta Joardar Routh, Advocate along-with some well wishers came to the house of my husband to discuss and settle the matter in dispute amicably but my husband, my in-laws and

my brother-in-law SRI KOUSTAV PAUL very badly and rudely misbehaved with them and insulted them with very abusive and filthy languages and Sri Koustav Paul also pushed my aunty Smt. Soma Dutta Joardar Routh out of the house due to with her cloth were torn off. Subsequently when my uncle Sri Arjit Dutta Joardar objected to their said illegal act and activities then suddenly my husband, my in-laws and my brother-in-law Sri Koustav Paul became more furious and started abusing them with filthy languages and defamatory unparliamentarily words. I along-with my uncle, aunty and other well wishers without aggravating the situation anymore avoided to counter them and left the place i.e., my matrimonial house to save our reputation.

Under the above facts and circumstances, I am requesting you to kindly register my FIR and investigate the case and take necessary action against my husband namely KOUSHIK PAUL, my father-in-law namely NITAI PAUL my mother-in-law SMT. SHIPRA PAUL and my brother-in-law SRI KOUSTAV PAUL under proper sections of law and put the wrongdoer behind the iron bar as they have committed the offence of cruelty by torturing me mentally and physically and also tried to cause harm to my life as I demanded my Stridhan Properties from my husband and his family and also insulted and defamed my uncle and aunty and also used assault and criminal force and tried to disrobe the modesty of my aunty.

I am further requesting you kindly recover my said Stridhan properties from my matrimonial house otherwise they shall misappropriate the same.
