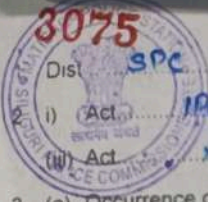

Sir,

With due respect, I, Kamal Biswakarma, s/o. Lt. Dale Biswakarma, R/o Helapakri, Pattharghatta, P.O - New Chumpta, P.S- Matigara, Dist - Darjeeling would like to lodge a FIR against 1. Kumar Biswakarma, 2. Nirmal Biswakarma both are son of late Dirjee Biswakarma R/o - Helapakri, Patharghatta, Matigara, Siliguri, Dist - Darjeeling -

1. That my father late Dalle Biswakarma had purchased a land measuring 32 decimal vide registered deed being number 1787, Book No-I from Late SantaMaya Biswakarma in the year 1989.
2. That my father Late Dalle Biswakarma is the sole owner of the said mentioned land and have not transferred the said piece and parcel of land to anyone through sale nor gift till date.
3. That after the death of my father Late Dalle Biswakarma in the year 03.08.2014, I went to mutate the said land in LR khaitan No - 1470, L.R and Plot No - 157 but prior to me above named Kumar Biswakarma and Nirmal Biswakarma had fraudently with malafide intention transferred 18 decimal of land which was purchased by my Father in the year 1989.
4. That recently on dated 31.01.2023, I again filed an application for mutation purpose but I was shocked to know that above named person frogedly disguised the Land Registrar at Bagdogra and also B.L.L.R.O Shivmandir and falsely mutated the said 18 decimal of land in their name in the year 2012. Vide Gift deed being No - 07407/2013 before ADJR Siliguri II at Bagdogra.
5. That my parents were illiterate having no idea of mutation and above named person taking the advantage of honesty had also taken the purchase amount and also transferred the land to his son.
6. That above mentioned land was in my family possession since 1986 from the date of purchase till today.

I would be grateful if the concerned authority may take immediate and necessary action to stop this fraud to the earliest. The arrest of the abovenamed persons are ultra-necessary to prevent the ongoing fraud.
