

Sir,

In producing herewith 01 (one) arrested accused person namely Sunny Karki Chettri(40), S/O- Lt. Ganesh Karki Chettri of Bijonbari, PO+PS- Bijobari, Dist- Darjeeling, A/P- C/O- Tamash Singha of Baraghararia, PS- Matigara, Dist- Darjeeling along with following articles under proper seizure.

- 1) 10 (Ten) sealed bottle of Kingfisher strong premium beer each bottle containing 650 ml, Total 6.5 liters, value Rs. 125/- each (total-125X10=Rs. 1250) marked as 'exhibit -A'.
- 2) One sealed bottle of Kingfisher strong premium beer each bottle containing 650 ml which was taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1"
- 3) 06(Six) sealed bottle of Budweiser MAGNUM beer each bottle containing 650 ml, Total 3.9 liters, value Rs. 175/- each (total-175X6=Rs. 1050) marked as 'exhibit -B'.
- 4) One sealed bottle of Budweiser MAGNUM beer containing 650 ml which was taken out from 'Exhibit -B' as sample for examination and marked as "Exhibit-B-1"
- 5) 12(Twelve) sealed bottles of Copenhagen TYRORG PREMIUM ORIGINAL GREEN BEER each bottle containing 650 ml, Total 7.8 liters, value Rs. 125/- each (total-125X12=Rs. 1500/-) and marked as 'exhibit -C'.
- 6) One sealed bottle of Copenhagen TYRORG PREMIUM ORIGINAL GREEN BEER containing 650 ml which was taken out from 'Exhibit -C' as sample for examination and marked as "Exhibit-C-1"
- 7) One sealed bottle of IMPERIAL BLUE Blended Grain Whisky containing 750 ml value Rs. 640/- and marked as "Exhibit-D".
- 8) One sealed bottle of BLENDERS PRIDE whisky containing 750 ml value Rs. 980/- and marked as "Exhibit-E".
- 9) One sealed bottle of Signature Premier grain whisky containing 750 ml value Rs. 990/- and marked as "Exhibit-F".
- 10) One sealed bottle of Dia Red Wine Sparkler containing 750 ml value Rs. 550/- and marked as "Exhibit-G".

I, ASI Prabir Roy presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person that today (28.02.2023) at 16.05hrs onwards while performing evening patrolling duty I received a specific source information that one Sunny Karki Chettri is selling and storing huge quantity of illegal liquor at his restaurant styled as "Plaza Restaurant" situated at Baraghararia, under PS- Matigara. Accordingly, I informed the fact to the Officer-In-Charge and as per his direction myself along with force left for Baraghararia, under PS- Matigara to work out the information in hand by Govt vehicle. After arrival at the spot and as identified by the source I held raid at the restaurant styled as "Plaza Restaurant and managed to detained one person who on being asked disclosed his identity as Sunny Karki Chettri(40), S/O- Lt. Ganesh Karki Chettri of Bijonbari, PO+PS- Bijobari, Dist- Darjeeling, A/P- C/O- Tamash Singha of Baraghararia, PS- Matigara, Dist- Darjeeling and stated that he is the owner of the restaurant. On being search the above noted seized articles are found inside the restaurant styled as "Plaza Restaurant. On demand he failed to produce any valid license/papers for selling and storing of such articles. Then, I seized the above mentioned articles under proper seizure list and subsequently arrested the above mentioned person under proper memo of arrest, observing all sorts of formalities. On further interrogation of the arrested accused person namely Sunny Karki Chettri it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made on 28.02.2023 in between 19.55 hrs to 21.05 hrs.

Under the above noted fact and circumstances, I, therefore pray before your good self that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person namely Sunny Karki Chettri(40), S/O- Lt. Ganesh Karki Chettri of Bijonbari, PO+PS- Bijobari, Dist- Darjeeling, A/P- C/O- Tamash Singha of Baraghararia, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
