Ganesh Karki Chettri of Bijonbari, PO+PS- Bijobari, Dist- Darjeeling, A/P- C/O- Tamash Singha of Baragharia, PS- Matigara, Dist- Darjeeling and stated that he is the owner of the restaurant. On being search the above noted seized articles are found inside the restaurant styled as "Plaza Restaurant. On demand he failed to produce any valid license/papers for selling and storing of such articles. Then, I seized the above mentioned articles under proper seizure list and subsequently arrested the above mentioned person under proper memo of arrest, observing all sorts of formalities.
