I, Prashanta Kumar Mahato, Assistant Engineer and Station Manager, Milanpally CCC do hereby lodge complaint against Mr. Dipen Kar, South Deshbandhupara near 4H Club Dist.-Darjeeling, at about 14:55 hours in pursuance of a secret information. I along with Mr. A. Mahandeo, DE(Electrical), Darjeeling Regional & Mr. Pranab Sikder, S.O., Darjeeling Region along with on duty mobile van personnel inspected the house after issuing notice and detected one service cable was connected from LT network like as regular line but he is not a consumer of WBSEDCL. On further checking, it was also found that Mr. Dipen Kar was consuming electrical energy for DOMESTIC purpose as mentioned in the inspection report by direct hooking from LT network by using 3 metre (approx.) service cable from Balcony of 1st floor.

As he has committed offence as punishable u/s 135(1)(a) of Electricity Act. Hence, I seized PVC cable (approx 3 metre) after preparing the seizure list duly signed by all. An inspection report was also prepared and necessary copies were served to the representative of Mr. Dipen Kar.

The physical load was found 1.18 kVA.

Therefore, you are requested to register a case u/s 135(1)(a) of Electricity Act against Mr. Dipen Kar and arrange for its investigation

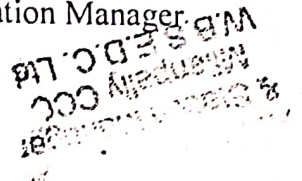
