Naren Saha of Ambikanagar, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at Hopital More area under NJP PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1225 date: 26.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV/824 Niru Kumar Jadav all of NJP PS, SPC left for Hospital More area, PS- NJP, Dist- Jalpaiguri to work out the information in hand. At about 1955 hrs we arrived at Hospital More, and being identified by the source I held raid the shop where the above noted accused person selling ID Liquior . Accordingly as per the indication of Source I managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain.
