

Sir,

I, SI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 26.02.2023 at 2145 hrs I received a secret source information that one person namely Gouranga Roy (65) s/o Lt. Mangal Ch. Roy of Kamrangaguri, PO- Satellite Township, PS- New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at Kamrangaguri, under NJP PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1237 date: 26.02.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, HG/794 Ranjit Roy, CV/116 Rohit Kumar Mahanto all of NJP PS, SPC left for Joynagar Colony, Purba Dhantala, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2155 hrs we arrived at kamranguri, and being identified by the source I held raid the shop where the above noted accused person selling ID Liquor but see the police team, the accused person fled away from the spot. On search I, recovered (i) 07 (Seven) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.) (ii) 05 (Five) Bottle of Himalayan 70 UP Fata Fati Country spirit (Each Bottle Containing 300 ml) in each bottle. from the hotel of Gouranga Roy (65) s/o Lt. Mangal Ch. Roy of Kamrangaguri, PO- Satellite Township, PS-New Jalpaiguri, Dist.- Jalpaiguri. Accordingly, I seized the above noted I/D liquor from the house of Gouranga Roy (65) s/o Lt. Mangal Ch. Roy of Kamrangaguri, PO- Satellite Township, PS-New Jalpaiguri, Dist.- Jalpaiguri under proper seizure list. The whole process of search & seizure was made in between 2215 hrs to 2245 hrs on 26.02.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Gouranga Roy (65) s/o Lt. Mangal Ch. Roy of Kamrangaguri, PO- Satellite Township, PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.


