In producing herewith one arrested accused person namely Ranjeet Kumar@Ray (29 Years) S/o Bidhan Ray Of Akkelpur, PO-Bahjaiya, PS-Dharyapur, Dist-Chhapra, Bihar along with the following seized articles as per seizure list viz:-

- 1) One Truck bearing registration no. NL-01-G/8536.
- 2) 14(fourteen) nos. of sealed packet wrapped with brown colour tape, seems to be Ganja weighing 16.130 kg, 16.112 kg, 16.152 kg, 16.134 kg, 16.106 kg, 16.108 kg, 16.032 kg, 16.140 kg, 16.090 kg, 16.110 kg, 16.120 kg, 13.300 kg, 16.090 kg, 16.174 kg (Total approx. 225.798 kg) and marked as Exhibit "A,B,C,D,E,F,G,H,I,J,K,L,M & N" respectively.
- 3) 02(two) nos. Mobile phone in which one is VIVO having IMEI No. 867205045968952 & 867205045968945 and another is Karbon having IMEI No. 358995134712164 & 358995134712172.
- 4) Amount of Rs.4960 having denomination 500x9=4500, 200x1=200, 100x2=200, 50x1=50, 10x1=10(Total Rs. 4960).
5. A copy of PAN Card being No. LLOPK3293D in the name of Ranjeet Kumar, S/o Bidhan Ray and his date of birth is 01.01.1994.

I, SI Sandip Dutta, O/C. Ambari-Falakata OP under NJP PS, Siliguri Police Commissionerate do hereby submit this written complaint to the effect that, on 27.02.2023 at 18.15 hrs, received specific reliable source information that, one Truck will proceed towards Mallbazar via Canal Road coming from Gandar More side with huge quantity of Ganja for disposing the same for his wrongful gain. The matter has been diarized in GD vide Ambari-Falakata OP GDE No-913, dated 27.02.2023. Accordingly, I informed the matter to O/C, NJP PS, SPC in writing a letter to him and expressed the entire information and as per his direction, myself along with SI Rakesh Debnath, SI Swadesh Saha, C/975 Swarup Basak, and C/V-001 Jaychand Roy all of Ambari-Falakata Out Post, SPC left for Canal Road near Nowapara More to verify the veracity of the information vide M.C.C No. 29/23 Dt. 27.02.2023 which refers to Ambari-Falakata OP GDE No. 913, Dt. 27.02.2023 by Govt. Vehicle bearing No. WB 62 A/7050 driven by Tapan Roy.

At the time of departure from Ambari-Falakata Out Post, I took envelopes, white papers, sealing wax, gum, seal, etc. At about 18.45 hrs we reached at Canal Road near Nowapara More and parked the vehicle at considerable distance of approx. 100 mtrs and on foot started proceeding towards Nowapara More and meanwhile called two independent witnesses namely (1) Bahadur Roy, S/o Najen Roy Of Dangapara, P.O-Balaram, PS-NJP, Dist-Jalpaiguri and (2) Jiten Das, S/o Lt. Bhubaneshwar Das of Do and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany with Police during raid, search and seizure. Being accompanied by source and the witnesses our whole police party started keeping watch over the ongoing vehicles in and around Canal Road near Nowapara More. At around 19:15 hrs amidst many vehicles one suspected vehicle was seen coming from Gandar More side and the source identified that the vehicle which containing huge quantity of Ganja. I alerted all my officers and force at Canal Road near Nowapara More and trying to stop the vehicle bearing registration No. NL-01-G/8536 but seeing the police party, the driver suddenly stop the vehicle and trying to flee away by abandoning the said vehicle. Therefore, we intercepted him and managed to apprehend him. On being asked the he produced before me a copy of PAN Card being PAN No. LLOPK3293D and disclosed his identity as Ranjeet Kumar@Ray (29 Years) S/o Bidhan Ray Of Akkelpur, PO-Bahjaiya, PS-Dharyapur, Dist-Chhapra, Bihar. Accordingly, we were approaching towards the abandoned vehicle and found that it was a Trailer bearing registration no. NL-01-G/8536. After that I informed the apprehended person namely Ranjeet Kumar@Ray (29 Years) S/o Bidhan Ray Of Akkelpur, PO-Bahjaiya, PS-Dharyapur, Dist-Chhapra, Bihar regarding our source information that he is carrying huge quantity of contraband Ganja in his vehicle bearing registration no. NL-01-G/8536 to dispose off the same for his wrongful gain and also offered him in writing to be searched him along with the vehicle bearing registration no. NL-01-G/8536 in presence of any Executive Magistrate or Gazetted Police Officer. Accordingly he has given in writing that he is willing to be searched by Gazetted Police Officer.

Therefore, I informed the same to Sri. Gyalsen Lepcha, ACP Traffic (HQ), SPC, and requested him to come at Canal Road near Nowapara More and to remain present and supervise the search and seizure as he being an Executive Magistrate. Accordingly at 19.55 hrs Sri. Gyalsen Lepcha, ACP Traffic (HQ), SPC arrived at the spot in uniform and disclosed his identity to the apprehended person and witnesses. I also offered the independent witnesses as well as the apprehended person to search our Police Party as per provision of law. But they refused to search the police party. Under the supervision of Sri. Gyalsen Lepcha, ACP Traffic (HQ), SPC and in presence of two independent and disinterested public witnesses searched the said vehicle bearing registration no. NL-01-G/8536 and found the above noted articles which are seems to be Ganja were kept concealed inside a special chamber of the above noted Trailer bearing registration no. NL-01-G/8536. I, accordingly count the all fourteen packets wrapped with brown colour tape and recovered the above noted articles seems to be Ganja from the Special Chamber of the vehicle bearing registration no. NL-01-G/8536.
