In producing herewith one arrested accused person namely Gautam Ray (M-28 yrs) s/o Late Karuna Ray of Majhabari (Purba) near Primary School PO, Bhugumali (Panchayet) PS- Bhaktinagar Dist- Jalpaiguri along with seized articles viz,

- 1] 15 (fifteen) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 155/- Marked as exhibit - A, out of one bottle randomly taken as sample for examination as sample. Marked as exhibit - A-1
- 2] One Nylon Bag which used for carrying the seized articles SL. No. 1.

I, ASI Surojit Mallick of Panitanki TOP under Siliguri PS, hereby lodge a written complaint against the above noted accused person to the effect that on 05.03.2023 at 18.05 hrs received a source information that one person is carrying huge quantity of bottled country spirit through Bidhan road near Bidhan Market Auto Stand under PS, Siliguri and selling the same on that area if come immediate he has been arrested. Accordingly the information was diarized vide Panitanki TOP GDE No. 92 dated 05.03.23 and informed to O.C, Panitanki TOP and thereafter as per his direction, I along with C/233 Nagen Ch Barman and C/1036 Gopal Srivastav left from Panitanki TOP to work out the information. On arrival at Bidhan road near Bidhan Market Auto Stand by Govt, vehicle at around 18.20 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag seeing the police team he tried to flee away a hot chase somehow we managed to apprehended. On interrogation he disclosed his identity as Gautam Ray (M-28 yrs) s/o Late Karuna Ray of Majhabari (Purba) near Primary School PO, Bhugumali (Panchayet) PS- Bhaktinagar Dist- Jalpaiguri on search his bag in presence of witnesses huge quantity of illicit liquor Country Spirit ie 15 (fifteen) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 155/- on demand the apprehended person Gautam Ray failed to produce any documents/license in support of possessing and selling the huge quantity of illicit liquors also he stated that for the purpose of Holi festival he procured the same for sale to his native village area on the local people ie Majabari village area under PS, Bhaktinagar illegally with a view to earn huge money. Also he confessed that since long he runs the said business ie selling of illicit liquors without any valid license. Accordingly, I seized the above noted articles ie (1) 15 (fifteen) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 155/- and 2) One Nylon Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labeled the same in presence of witnesses and duly signed by them and accused person. The seizure and label was made in between 18.25 hrs to 19.05 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C,

Hence, I am submitting this written complaint against the above accused person namely Gautam Ray (M-28 yrs) s/o Late Karuna Ray of Majhabari (Purba) near Primary School PO, Bhugumali (Panchayet) PS- Bhaktinagar Dist- Jalpaiguri with a request for starting a specific case under proper section of Law and to arrange for its investigation.
