CV/158 Partha Sarkar all of NBMC OP left for Kawakhali New Township under NBMC OP to verify the veracity of the information by Govt vehicle having Reg No-WB74Q/8035 being driving by CV-920 Kamal Barman vide NBMC OP GDE No-109 dated 04/03/2023 and MCC No- 346/23 dated 04/03/2023. I also brought the necessary tools like weighing mechine, Gala, Seal, and Candle etc. On the way to Kawakhali New Township, I called two independent witnesses namely [1] Bhubaneshar Sahani S/O Lt Jogindar Sahani of Kawakhali, PO Sushruta Nagar, PS Matigara, Darjeeling and [2] Uttam Biswas @ Santu S/0 Sukumar Biswas of Kawakhali Bidhan Pally PO Sushruta Nagar, PS Matigara, Darjeeling and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. Then 00:05 hrs myself along with my accompanying party arrived at Kawakhali New Township and contacted my source. At 00:10 hrs as identified by my source myself along with my accompanying party surrounded the above noted accused person's having three Gunny bags in his possession which he had kept in his Scooty ((ACTIVA 5G) having Registration WB74AX/0659 while standing and waiting for someone. (Exhibit A & B was kept on foot floor of Scooty and Exhibit C was kept on the backside of the seat of said scooty which was tiding by roap). On being asked he disclosed his identity as noted above. On further interrogation he stated that the content inside the Gunny bags in his possession is Ganja. After disclosing our identity I asked him whether he have any objection to be searched in presence of any Executive Magistrate or Gazetted officer. He agreed to be searched in presence of any Executive Magistrate or Gazetted Officer. Accordingly I served him a notice in accordance with the provisions of law in this regard. Then at 00:35 hrs of 05/03/2023 I apprised Shri Suraj Thakuri, Asstt. Commissioner of Police, Siliguri Police Commissionerate holding the power of special Executive Magistrate over telephone and requested him to remain present at the spot as special Executive Magistrate. At 00:55 hrs Shri Suraj Thakuri, Asstt. Commissioner of Police, Siliguri Police Commissionerate holding the power of special Executive Magistrate arrived at the spot. I disclosed the identity of Shri Suraj Thakuri, ACP, Siliguri Police Commissionerate before the accused person as Special Executive Magistrate. He further confessed in presence of Shri Suraj Thakuri, ACP(HQ), holding the power of Special Executive Magistrate, and other witnesses that he procured the Ganja from Cooch Bihar clandestinely for the purpose of its selling its to Smt Sumitra Gowala and others of Kawakhali Neemtola area with a view to earn huge money quickly. On interrogation he disclosed that he had been dealing in such business for last few years importing it from Cooch Bihar and selling the same to Smt Sumitra Gowala and others of Kawakhali Neemtola and its adjacent areas. Accordingly I examined him and recorded his statement u/s 67 NDPS Act in separate sheet of paper. On being asked he failed to produce any documents or license in support of his possession of Ganja. Then as per the direction of Shri Suraj Thakuri, Asstt. Commissioner of Police, Siliguri Police Commissionerate I weighed the contains seems to be Ganja with weighing instrument and found that weight of (a) 01 (One) plastic gunny bag which contains said to be Ganja is 7(Seven) Kgs 844 Grams, marked as exhibit - "A"
