Madam,

I, Shmt. Manita Rai Lohar w/o Shri
Puran K. Lohar of Indira Apartment, Ground Floor,
Ashrampara, Siliguri have the honour to state
that above mentioned my husband has
been mentally torturing since long time
in consequence of which I have been living
separately renting a house which did not
stop even after living separately.

On Yesterday, i.e., 5th March, 2023 around
9.30 A.M. he barged into my rented house
at Medical More, Siliguri and abused me and
my mother aged 76 years including my
younger sister, Shmt. Sushilta Mukhiya even
to the extent of physical abuse.

Before that too, Madam, he had humiliated
me publicly at the golden jubilee celebration
programme of the Bal Krishna Sangha at
Shastri Nagar, Siliguri on 6th November, 2022 of
which there are many witnesses.

That, Madam, I am a government employee
serving as Sister-in-Charge at North Bengal Medical
College and Hospital, Sushrutanagar, Siliguri

where he comes frequently and uses abusing words before my colleagues. He also does not spare my colleagues and fellow co-workers in the Bharatiya Gorkha Mahila Parishad of which I am the chairperson of the Siliguri Kshetriya Samiti, the Siliguri chapter. They have often been the victim of his insult and humiliation. Sometimes, I fear physical assault from him from the way he behaves.

Therefore, Madam, I request your honour to kindly look into matter and take appropriate action against him at an earliest possible opportunity.
