As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/824 Niru Kumar Yadav, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Kachagali, PS- NJP, Dist.- Jalpaiguri to work out the information in hand.
