I, Mohit Agarwal, son of Sri Sushil Kumar Agarwal, and Director of HANUMAN MACHINERIES PVT., LTD. having its business place of Bidhan Market Road, "Pandit Mansion", Ground Floor, Post Office and Police Station Siliguri, District- Darjeeling, I write to you as follows:

Sir, the nature of my business is carrying on supply of Tea machine and other various machinery parts to different Tea Garden and others and Nova Hightech Pvt., Ltd., Neclamber Building, 28 B, Shakespeare Sarani, 3rd Floor, Kolkata- 700 017 is one of the sellers of the above machines.

On 08.10.2021 I, placed my order to Nova Hightech Pvt., Ltd., to purchase 100 numbers of "Mitsubishi Engine Powered Tea Pruning Machine", 01 "Single Man Tea Harvester", 01 "Two Men Tea Harvester" and other parts etc, to supply those machines to me so that I can deliver the said machines to my customers and the above named Mr. Sanjay Kumar Garg, Chief Executive Officer and Mr. Sanjib Sukul, Executive Director, Nova Hightech Pvt., Ltd., duly accepted the said order to supply the above machines and its parts etc.

That on 09.10.2021 the above Company send Pro-forma Invoice to me for Mitsubishi Powered Tea Pruning Machine etc., and as per their instructions and demand I transferred a sum of Rs. 7,00,000/- (Rupees Seven Lakh) only on the same day to the said Company as advance and also requested them to supply all the machines by the month of November 2021.

I received the above machines in the month of January 2022 and sold some machines from the above machines to the purchasers, but after elapsed of some months, all of the machines refunded/returned back by the purchasers because all those machines are found duplicate.

I duly informed the matter and requested Mr. Sanjay Kumar Garg and Mr. Sanjib Sukul above named to change those duplicate machines and supply the original and genuine machines so that I can replace those duplicate machines to my customers as well as to maintain my good will of business, but they did not pay any heed. It is to be needful to mention here that I ordered the above company to supply the Original and genuine machines and paid the price of the Original and genuine machines.

Sir, initially, the above named Mr. Sanjay Kumar Garg and Mr. Sanjib Sukul assured me to replace those duplicate machines but did not take appropriate steps to do so therefore, on 24.12.2023 and 09.02.2023, I compelled to issue notices to them demanding the replace of those duplicate machines or to refund the sum paid by me for the above machines. Receiving my above notices the above named Mr. Sanjay Kumar Garg and Mr. Sanjib Sukul replied on 06.02.2023 and 17.02.2023 and refused to replace those duplicate machines or to refund the amount paid by me to them.

Sir, the above named MR. SANJAY KUMAR GARG and MR. SANJIB SUKUL cheated me by sending me the duplicate machines and thereby breach my trust and they also practice the illegal Trade practice.

Sir, due to their above activities, I and my customers also suffered irreparable loss and injury.

Sir, I therefore pray before you to investigate the matter and take necessary legal action against the above named miscreants for the ends of justice.

Hope your kind co-operation and needful immediate action against the above named persons for the ends of justice and thereby oblige.
