A pharmacy has also been set up on the said Hospital for selling of medicine. Md. Sakimul Islam of Kawakhali, Shushrutanagar, P.S. Matigara, and Pintu Saha of Rupsing, Dakshin Bagdogra, P.S. Bagdogra are responsible for the day to day affairs of the said pharmacy including sale of medicine and to collect/receive the sale price. The said Md. Sakimul Islam (Employee ID-SPHM0183) and Pintu Saha (Employee ID-PNMS0850) have joined our organisation on 23/06/2017 and 10/06/2022 respectively.

Day to day accounts of sale of medicines and receipts of sale price have been maintained in an application named as System, Applications & Products in Data Processing (in short SAP) has been installed in the computer of the pharmacy and the entries of the sale transactions of medicine and by whom medicine is sold are recorded and available in the said SAP. Md. Sakimul Islam and Pintu Saha have been operating SAP using their secret ID's which are not known to the other staffs of the Hospital.

In the present audit it is detected that during August, 2022 to January, 2023 said Md. Sakimul Islam misappropriated a sum of Rs. 4,92,916/- (Rupees Four Lacs Ninety Two Thousand Nine Hundred Sixteen] only and Sri Pintu Saha misappropriated a sum of Rs. 31,255/- (Rupees Thirty One Lac Two Hundred Fifty Five) only in course of discharging their official duty in the pharmacy. It is to be mentioned here that even the said Md. Sakimul Islam has on writing admitted that he has misappropriated a sum of Rs. 12,000/- from pharmacy's cash box via his letter dated 06/02/2023 addressing the Manager, Desun Hospital, Siliguri, the copy of which is attached herewith. We have noticed this incident on 06/02/2023 which took place in our Desun's pharmacy situated at Siliguri.

Md. Sakimul Islam and Sri Pintu Saha, being entrusted with the medicines of Desun Hospital and having dominion over the same, misappropriated a sum of Rs. 5,24,171/- in total and thereby they committed criminal breach of trust.
