



Sir,

In producing herewith one arrested accused person named Gyan Sharma (54) s/o Late Narayan Sharma of Dhukuria, PS-Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

1. 05 (Five) Bottles of "Cosmos Fifty Deluxe Whisky" each Bottle containing 350 ml [Total 1.75 Ltrs] and marked as Exhibit "A" out of which 01 (One) bottle of "Cosmos Fifty Deluxe Whisky" each Bottle containing 350 ml. taken as sample for examination and marked as Exhibit "A-1".

3. 10 (Ten) Bottles of "Cosmos Fifty Deluxe Whisky" each Bottle containing 180 ml [Total 1.8 Ltrs] marked as Exhibit "B" out of which 01 (one) bottle of "Cosmos Fifty Deluxe Whisky" each Bottle containing 180 ml. taken as sample for examination and marked as Exhibit "B-1".


I, SI Agen Lepcha of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused namely Gyan Sharma (54) s/o Late Narayan Sharma of Dhukuria, PS-Matigara, Dist.-Darjeeling to the effect that today on 11.03.2023 at about 18:58 hrs while performing PC mobile van duty at PS area received a specific source information that one Gyan Sharma (54) s/o Late Narayan Sharma of Dhukuria, PS-Matigara, Dist.-Darjeeling is selling illicit liquor at his house situated at Dhukuria under Matigara PS. Accordingly, I informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction I, along with C/1053 Paresh Rava, and CV/155 Sukumar Das both of Matigara PS left for Dhukuria, PS- Matigara, Dist.-Darjeeling to work out the information in hand. After reaching at Dhukuria and being identified by the source we held raid at the house of Gyan Sharma and managed to apprehend him. On being asked he disclosed his identity as noted above and also ststed that he has been selling illicit liquor at his house without any license for his wrongful gain. On being searched at his house we managed to recovered huge quantity of illicit liquor from his house. On demand he failed to produce any valid license/papers for selling and storing of illicit liquor at his house. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above noted person named Gyan Sharma (54) s/o Late Narayan Sharma of Dhukuria, PS-Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 11.03.23 in between 19:50 hrs to 20:30 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Gyan Sharma (54) s/o Late Narayan Sharma of Dhukuria, PS-Matigara, Dist.-Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
