Sir,

With due respect and humble submission, I, Vinod Kumar rai, S/o. Late Ramanand Rai, R/o. Kolabari, Ranjit Nagar, P.O. Champasari & P.S. Pradhan Nagar, District – Darjeeling, West Bengal would like to apprise you that Sri. Akhilesh Yadav, S/o. Ram Chandra Yadav, R/o. Kolabari, Debidanga is my brother-in-law by relation, due to a personal dispute with one Smt. Soni Devi, W/o. Manoj Mahato, R/o. Debidanga Kolabari, lodged one complaint before against my aforementioned brother-in-law before your respected station on 10.03.2023. In the said complaint Smt. Soni Devi alleged that she was in an extramarital affair with my said brother-in-law and currently due to some conflict she has filed the abovementioned complaint subsequently, the said complaint has been registered before your concerned police station, Pradhan Nagar Case no. 164/2023.

In the abovesaid circumstances dispute I have never supported my brother-in-law in any manner whatsoever and after the arrest of my brother-in-law in no way I have tried to make a contact with the same. I shall not intervene between your concerned authority & my brother-in-law during the trajectory of the law when it will be enforced upon my brother-in-law.

Today at about 1:45 P.M. I received a telephone call from the father of Smt. Soni Devi, namely Sri. Chandeshwar Mahato and I were apprised of threatening messages with false and baseless allegations. I work as an insurance agent under LIC by designation and today after my daily collection when I returned to my

house at 3:30 P.M., all of a sudden, some persons namely Smt. Soni Devi, Smt. Bimal Devi, Smt. Raj Kumari Devi, Sri. Papu Mahato, Sri. Dipak Mahato, Smt. Asha Devi Mahato, & Sri. Rohit Mahato, they trespassed at my house and started abusing me and the female member of my family thereafter I tried to console them of my personal circumstances that my minor daughter namely Nidhi Ray is in preparation for her upcoming examination i.e., madhyamik apparently, they insulted and abused my minor daughter, hence after such circumstances when I and my wife intervened in this situation, they started assaulting me and my wife.

It is important to note here that since the majority of the persons who assaulted me and my family were females thus, I couldn't resist them because of this incident I and my wife namely Indra Ray and my minor son namely Nishant Ray succumbed to injuries and at current my wife has been admitted to the Siliguri Hospital. It is pertinent to mention here that when they encroached over my house and started assaulting me with fists and blows, they also forcibly confiscated some of my and my wife's essential items such as earrings & ornaments and my personal bag which had an amount of Rs. 3,25,000 /- (Three lakhs and twenty-five thousand) therein.

We do not know the reason for their act of assailing me and my family and afflicting the same, I am in a deprived state of affairs due to apprehension that they may reiterate their mala fide acts again upon me and my family and also, they have threatened me, particularly that they would murder me first.

Henceforth, in view of the abovementioned facts and circumstances, it is my sincere request to your respected authority to kindly look into this matter and take strict action against the abovementioned persons and punish them according to the law.
