Sir,

In producing herewith one arrested accused person named Bablu Singh (30) S/O Jiban Singh of Dhukuria, Patharghata, PS-Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

[1] 03 (Three) Bottles of "McDowells No-1 Celebration rum" each Bottle containing 750 ml [Total 2.25 Ltrs] and marked as Exhibit "A" out of which 01 (One) bottle of "McDowells No-1 Celebration rum" containing 750 ml. taken as sample for examination and marked as Exhibit "A -1".

[2] 03 (Three) Bottles of "Old Monk XXX rum" each Bottle containing 750 ml [Total 2.25 Ltrs] marked as Exhibit "B" out of which 01 (one) bottle of "Old Monk XXX rum" containing 750 ml. taken as sample for examination and marked as Exhibit "B-1".

[3] 04 ( four) bottles of "Himalayan Gold 60 UP country Spirit" each bottle containing 600 ml [total 2.4 Ltrs] marked as Exhibit "C" out of which 01 (one) bottle of "Himalayan Gold 60 UP country Spirit" containing 600 ml taken as sample for examination and marked as Exhibit "C-1".

I, ASI Tapan Das of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused namely Bablu Singh (30) S/O Jiban Singh of Dhukuria, Patharghata, PS-Matigara, Dist.-Darjeeling to the effect that today on 12/03/2023 at about 16:25 hrs while performing PC mobile van duty at PS area received a specific source information that one Bablu Singh (30) S/O Jiban Singh of Dhukuria, Patharghata, PS-Matigara, Dist.-Darjeeling is selling illicit liquor at his house situated at Dhukuria, Patharghata under Matigara PS. Accordingly, I informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction I, along with C/ 974 Mintu Sen, and C/219 Sanatan Chitrakar both of Matigara PS left for Dhukuria, Patharghata PS- Matigara, Dist.-Darjeeling to work out the information in hand. After reaching at Dhukuria, Patharghata and being identified by the source we held raid at the house of Bablu Singh and managed to apprehend him. On being asked he disclosed his identity as noted above and also stated that he has been selling illicit liquor at his house without any license for his wrongful gain. On being searched at his house we managed to recovered huge quantity of illicit liquor from his house. On demand he failed to produce any valid license/papers for selling and storing the illicit liquor at his house. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above noted person named Bablu Singh (30) S/O Jiban Singh of Dhukuria, Patharghata, PS-Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 12/03/23 in between 18:50 hrs to 19:30 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Bablu Singh (30) S/O Jiban Singh of Dhukuria, Patharghata, PS-Matigara, Dist. Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
