This is to bring to your kind notice that Mr Bikash Sarkar (Mobile 9641082087), S/o Bidhan Sarkar (Mobile 9832381628), resident of N. M. Sarani, Bhaktinagar, has been working as a Assistant Manager at our Petrol Pump (Joy Service Station) for the past 2 Years, he has committed fraud and has stolen approximately 11 Lakhs over a period of 9 months. He had withdrawn cash from the ledgers of our Customers. This misappropriation of cash came to our notice while we were reconciling the ledgers of our Customers.

On 10th December, we initially came to know about misappropriation of Rs 4,53,402.72 from the ledger of M/s Himalayan Logistics and Bikash Sarkar also agreed to the same on that day. We had taken written letters from him on the same day. However later on when we checked ledgers of other parties many more differences have come to light.

Hence, the Total Estimated amount of misappropriation of has come out to be Approximately 11 Lakh Rupees.

Bikash Sarkar, had acknowledged his wrongdoing and had given us 2 Cheques drawn on State bank of india, First Cheque No. 00793249 dated 25/12/2022 of Rs 5 Lakhs and Second Cheque No. 00793250 dated 25/01/2023 of Rs 5 Lakhs. Both these cheques were deposited into the Bank and was returned by the Bank as the Account of Bikash Sarkar was Blocked.

We request you to kindly take note of the matter and lodge an FIR against the said person and take appropriate action at your earliest convenience.
