In producing herewith the following accused persons namely (1) – Raju Roy (28) S/O Lt. Bhola Roy of Sroban Nagar, Bagracourt, W/No-20, P.S - Siliguri Dist. Darjeeling (2)- Bijay Kr, Chhetri (50) S/o- Prem Bahadur Chhetri of Matigara Bazar, P.S - Matigara, Dist. Darjeeling (3) – Bikram Sahani (32) S/O Khader Sahani of Babupara, Gosawala, P.S Siliguri Dist. Darjeeling after producing them under arrest along with following articles; (i) 03(three) Pcs. Table Cart Boards writing different digit in English (ii) Two Mobile Phone one NOKIA Model No. 1200 and another LYF/Jio (iii) 03 (three) pcs. Note Book (FORTUN) written different digit in English in it (IV) Cash of Rs. 2540/- (two thousand five hundred and forth only) Board Money (v) 5 (five) Blue and Red Ball Pen and sketch pen and (vi) 3 (Three) Candle under proper seizure.

In this regard, I, S.I. Basudeb Guha, of Siliguri PS, under Siliguri Police Commissionerate, beg to report that on 18.03.23 at 15:25 hrs received a source information that the some persons are playing gambling with one digit (Satta) at Sarbohara colony under Mahabirstan Fly Over Siliguri in a bamboo thatched. Shared the information with the I.C. Siliguri PS and as per direction of I/C Siliguri P.S, Myself along with ASI Debasish Das, ASI Siben Sarkar, ASI Subir Sen, CV 283 Prasanjit Dey and CV/622 Ramanath Barman rushed to the at Sarbohara colony under Mahabirstan Fly Over Siliguri vide Siliguri P.S GDE No. 1035 Dt. 18.03.23. On reaching at the spot, parked the vehicle at considerable distance and briefed my accompanying force. On being shown by the source, we proceeded to place where the accused were gambling with playing one digit (Satta). Meanwhile, I called disinterested witness namely i) Dipankar Sarkar (27) S/O- Raton Sarkar of Lichubagan, Subashpally, W/No- 18, P.S Siliguri Dist. Darjeeling 2) Jitendar Singh (32) S/o – Rambilash Singh of Sroban Nagar, Bagracourt P.S Siliguri Dist. Darjeeling who were present at Sarbohara colony under Mahabirstan Fly Over Siliguri and requested them to accompany us during raid, search and seizure. I, then, along with force conducted raid. On seeing police party some of gambler flee away from the spot in the different direction but we able to apprehended the above noted persons on the spot and searched the place in presence of independent witness and seized the above noted gambling articles duly signed by witnesses and accused persons. On interrogation, they disclosed their name as mentioned above. They admitted that they were gambling with playing One Digit (Satta) clandestinely at Sarbohara colony under Mahabirstan Fly Over Siliguri causing wrongful gain to one and wrongful lost to others. On interrogation they denied to identify those who flee away. Accordingly I arrested the above noted accused persons and issued memo of arrest against them appearing them reason of arrest and supplied one copy to them.

I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the above noted arrested accused persons namely (1) – Raju Roy (28) S/O Lt. Bhola Roy of Sroban Nagar, Bagracourt, W/No-20, P.S - Siliguri Dist. Darjeeling (2)- Bijay Kr, Chhetri (50) S/o- Prem Bahadur Chhetri of Matigara Bazar, P.S - Matigara, Dist. Darjeeling (3) – Bikram Sahani (32) S/O Khader Sahani of Babupara, Gosawala, P.S Siliguri Dist. Darjeeling and arrange for its investigation.
