
I, the undersigned, Sri Sumiran Chettri, Son of Late Kamal Chettri, cluster head of Siliguri Retail points of Placewell System & Solution Pvt. Ltd. having its registered office at Hill Cart Road, Besides Hotel Vinayak, Siliguri, Post Office & Police Station- Siliguri, PIN- 734001, District- Darjeeling, West Bengal and one of our branch office at City Centre, Shop No. B-18, ground Floor, Uttorayon, Siliguri, PIN-734010, District- Darjeeling, West Bengal would like to inform you about a serious malpractice which is being committed by duo Sri Sushil Thakur(9832920048), Son of Baleshwar Thakur, permanent resident of Sema pur, Debi Barata, Sema pur Factory, Barari, Kathia Bihar, PIN-854115, presently residing at Mahanandapara beside Modern Boys Club, Post office and Police Station - Siliguri, District - Darjeeling a former employee of our company who resigned in the month of January 2023 and started his own venture in the same line of business as ours under the name and style 'M/s. Ansh Computers' which is situated at Sevoke Road, Panitanki More opposite Laptop Bazar, 1st Floor, Siliguri, Post Office & Police Station-Siliguri, PIN- 734001, District- Darjeeling, West Bengal in active collusion and connivance with Sri Ajay Ganguly(9832038042/7908165054), Son of Nirmal Chandra Ganguly permanent resident of Ashok Nagar, Road No. 8, Siliguri Bazar, Rajganj, District- Jalapaiguri, PIN- 734005 who is working as an employee of our company since long and as a Showroom Manager supervising and managing our store situated at City Centre since the last 10 years. Of late it has come to our knowledge that Sri Ajay Ganguly in the most illegal manner has been passing leads about our customers and diverting all our customers to Fage - 1 - of 3

Sri Sushil Thakur's store i.e. M/s. Ansh Computers by misleading and claiming before them that M/s. Ansh Computers is directly associated and is a part of our company which is utterly false. The entire chain of event was very cleverly orchestrated by the duo wherein Sri Ajay Ganguly would direct our customers to Sri Sushil Thakur by sharing his phone number and would mislead our customers by stating before the customers that the required stock/product is/was not available with our store and the stock/products would be available at M/s. Ansh Computers. The Duo did this by impersonating M/s. Ansh Computers to be a part of Placewell System & Solution Pvt. Ltd.

It is pertinent to state here that this illegality is being committed by them since the last 3-4 months and we already had serious doubts as the footfall of our customers and the sales were not matching at all. As per our records and internal enquiry we have lost almost 70% of our customers due to the acts and conducts of the duo i.e Sri Ajay Ganguly and Sri Sushil Thakur. Our suspicion was verified once we caught the duo red handed committing the illegality. Furthermore immediately our company did an stock audit on 16.03.2023 where it was reported that stock amounting to Rs.51,722/-(Rupees fifty One Thousand, Seven Hundred Twenty Two only) was missing. The same was misappropriated by Sri Ajay Ganguly, list of which is attached for ready reference in Annexure – A (Page 1 & 2) submitted.

Most of the customers visiting our showroom were told by Sri Ajay Ganguly that there are no stock in our showroom and the same would be available in another store of ours by the name M/s. Ansh Computers. By such deception said Ajay Ganguly in connivance and collusion with Sushil Thakur would induce our customers to leave our showroom and visit M/s. Ansh Computers under wrong impression as if was our store and would complete their motive of taking our customers.

Thus it is apparently clear that Sri Sushil Thakur & Sri Ajay Ganguly committed breach of trust, misappropriated and cheated us of our money for

his illegal gain and profit. They have committed the crime of cheating being agents of the company.

I, therefore request you to take note of the aforesaid matter and book the culprits i.e. Sri Sushil Thakur & Sri Ajay Ganguly in accordance to the appropriate provisions of the Criminal Law.
