

Sub: - F.I.R

In producing herewith two (02) arrested accused persons namely Ahmed Mansuri (24) s/o Lt. Sagir Mansuri of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling and (ii) Aditya Singh (19) s/o Sumod Singh of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling with the following articles under proper seizure as per seizure list;

a) One Black Plastic pouch containing 317 grams of Brown Sugar, which was found in one black and red colour scooty styled as TVS NTORQ having number pasted as WB 74 TC 969, recovered and seized from the joint possession of Ahmed Mansuri and Aditya Singh and marked as "Exhibit- A".

b) 25 Grams of Brown Sugar taken from Exhibit A and taken as sample for examination and marked as

Exhibit "A-1".

c) One black and red colour Scooty styled as TVS NTORQ having number pasted as WB 74 TC 969.

I, SI Abhishek Theengh (32), S/O- Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons namely Ahmed Mansuri (24) s/o Lt. Sagir Mansuri of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling and (ii) Aditya Singh (19) s/o Sumod Singh of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling to the effect that on 24.03.2023 at about 21.05 hrs, I received a specific source input that two persons possessing huge quantity of Brown Sugar based drugs was standing in front of Hotel Heritage Parking lot under Pradhan Nagar PS to sell the same to their designed local customers. The matter was diarized in Pradhan Nagar PS GDE No. 1420/23 Dt. 24.03.2023. Subsequently, I informed the matter to you on written and with your prior permission and being directed, myself along with ASI Tarun Kanti Ghosh, ASI Ashit Singh, C/762 Majibul Rahaman, CV/28 Ajay Sahani, CV/223 Swapan Chettri, CV/645 Pankaj Gupta, all of Pradhan Nagar PS, SPC, and with SOG Team consisting of ASI Binod Jha, CV/123 Ratul Bhattarcharya and CV/145 Bijoy Das, after being contacted to the Videographer Somnath Chatterjee S/O Sushil Chatterjee of Arubindo Pally, P.O.- Rathkhola, P.S. - Siliguri, Dist. - Darjeeling and with investigation kit left in front of Hotel Heritage Parking lot under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 1422/23 Dt. 24.03.2023 and M.C.C No- 795 Date- 24.03.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

After reaching in front of Hotel Heritage Parking lot under Pradhan Nagar at around 21.05 hrs, I requested two persons as independent witness by notice namely (1) Dhananjay Rajbhar (40) s/o Shri Ram Rajbhar of Gurung Busty, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling and (2) Pappu Ali (32) s/o Md. Safar Ali of Jalpaimore, PS Siliguri, Dist. Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and thereafter being pointed by my source detained 02 (Two) persons mentioned above who were on the above mentioned scooty and was ready to move from in front of Hotel Heritage Parking lot under Pradhan Nagar PS. Thereafter, we disclosed our identity and the information in hand and stated him that they as well as the scooty under their possession will be searched for the purpose. And, I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above.

I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but they did not search the police party. Consequently, I informed the matter to you and as per your kind order, I informed to Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Brown Sugar illegally and requested him to come in front of Heritage Hotel Parking lot under Pradhan Nagar PS to remain present and to supervise the search and seizure.

Accordingly at 21.55 hrs Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot in front of Heritage Hotel Parking lot under Pradhan Nagar PS as Special Executive Magistrate, SPC and in presence of two independent witnesses and hereafter I searched the detained persons and the scooty under their posession following all formalities, keeping their decency and recovered the above noted articles from black and red colour Scooty styled as TVS NTORQ having number pasted as WB 74 TC 969 which was under their joint possession of the accused persons namely Ahmed Mansuri (24) s/o Lt. Sagir Mansuri of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling and (ii) Aditya Singh (19) s/o Sumod Singh of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling.



It has been found One Black Plastic pouch containing 317 grams of Brown Sugar was kept by them under the seat of one black and red colour Scooty styled as TVS NTORQ having number pasted as WB 74 TC 969 of the above noted accused persons namely Ahmed Mansuri and Aditya Singh and the details has been mentioned in details below during the seizure process.

Further, on demand in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, the detained persons namely Ahmed Mansuri and Aditya Singh, on being asked, failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of Brown Sugar beyond the prescribed limit.

Thereafter, I seized 317 grams of Brown Sugar, which was recovered inside the seat of one black and red colour scooty styled as TVS NTORQ having number pasted as WB 74 TC 969, under their joint possession and seized in front of Hotel Heritage, Parking lot under Pradhan Nagar PS under proper seizure list in presence of independent witnesses and Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused persons.

Subsequently, I labelled and sealed the seized articles in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused persons namely Ahmed Mansuri and Aditya Singh. The whole process of seizure was made in between 22.05 hrs to 23.08 hrs with the videography.

Being further asked, the apprehended persons namely Ahmed Mansuri and Aditya Singh admitted in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that they have procured Brown Sugar clandestinely for the purpose of selling the same in high rate to their designed local customers for their personal gain by illegal means. On further being asked, they also disclosed that they have been dealing in this business of procuring and selling of Brown Sugar based drugs illegally for last few months for their wrongful gain who has been chiefly selling in Siliguri and its adjacent areas.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Ahmed Mansuri and Aditya Singh is involved in procuring and selling Brown Sugar based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Ahmed Mansuri and Aditya Singh after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest at 23.10 hrs and 23.12 hrs respectively.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Ahmed Mansuri (24) s/o Lt. Sagir Mansuri of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling and (ii) Aditya Singh (19) s/o Sumod Singh of BRI Colony, Ward No.1, PS Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
