Sir,

I SI (UB) Raju Sarkar of Bhaktinagar Traffic Guard, Siliguri Police Commissionerate beg to lodge a written complaint, that on 24.03.2023 around 19:30 hrs while on duty at Bhaktinagar Tri Junction on NH-10 under Bhaktinagar Police Station found 01(one) TOTO without any registration number he is carrying dangerously Heavy loaded good article Air Compressor Machine in the TOTO near Bhaktinagar check post more in such a way causing hindrance and danger to the general public and others.

Accordingly I detained the said TOTO and on being ask the driver disclosed his identity as Md Mofiz (48 Yrs) S/o-Md Suleman ward no .03 Fataut Phaphot P.S- Meghaul Dist -Begusarai, Bihar as per Aadhar Card. Further on being asked to produce relevant documents in support of their claim of plying TOTO on Major road, he failed to produce the same.

Accordingly, I Seized the above noted without number TOTO Along with fully loaded goods (Air Compressor Machine) in proper seizure list also arrested him U/S 41 CrPC.

Therefore I would request you to kindly start a specific case in terms of U/S-188/283 IPC and other Proper Section of Law against the said driver with necessary action as applicable.
