Sub: FIR against Pilferage of Electricity

Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mrs. Sonamani Roy, W/O- Subodh Roy, Village- East Hatiyadanga, P.O. - Sahudangi Hat, PS- Bhaktinagar, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401661505), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose as stated here under.

On 24.03.2023 at about 15:55 Hours, I, Sri Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Pranab Sikdar, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 2. Mr. Arnab Ray, J.E.(E) (Grade-II), attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mrs. Sonamani Roy, W/O- Subodh Roy, Village- East Hatiyadanga, P.O. - Sahudangi Hat, PS- Bhaktinagar, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401661505), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, Mrs. Sonamani Roy, W/O- Subodh Roy, Village- East Hatiyadanga, P.O. - Sahudangi Hat, PS- Bhaktinagar, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401661505), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnecting the 'Deemed Disconnected' service connection having Consumer ID: 401661505 & Meter No.: L4899243 which was disconnected on 31.08.2021 due to having outstanding dues of electricity of Rs. 5693.16 (excluding LPSC). Moreover, the last meter consumption recorded before disconnection was 2190 KWH on 31.08.2021 (i.e. during disconnection) & during inspection on 24.03.2023, the last reading was found 2726 KWH dated: 24.03.2023. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As Theft was detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number Single Phase Energy Meter having SI No.: L4899243, make: Landis-Gyr, Rating: 240V, 5-30A, 3200 imp/unit (L.R.: 2726 KWH) connected with some portion of two numbers Red & Black Colour PVC Insulated Aluminum Incoming Wires & two numbers Yellow colour PVC Insulated Copper outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 401661505) & consuming electricity dishonestly in unauthorized manner at the mentioned Domestic premises for the Domestic purposes under a proper seizure list duly signed by the Inspection Team Members & Witnesses & Witness of the Accused Person (i.e. nephew & brother-in-law). The seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & Witness of the Accused Person (i.e. nephew & brother-in-law). However, Copies of Notice, Inspection Note & Seizure List were handed over to the witness of accused person at the inspection spot. The inspection team members left the aforesaid premises at 16:25 Hours on the same day after observing all formalities.

So the accused Mrs. Sonamani Roy, W/O- Subodh Roy, Village- East Hatiyadanga, P.O. - Sahudangi Hat, PS- Bhaktinagar, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401661505), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
