Sir,

In producing herewith four (04) arrested accused persons namely (i) Suraj Mandal @ Gholta s/o Lt. Ganesh Mandal of Mahakal Pally, near Surya Sen Park, PS Bhaktinagar, Dist. Jalpaiguri (ii) Rakesh Trikhatri (40) s/o Lt. Narjit Trikhatri of Gurung Busty near SNT, PS Pradhan Nagar, Dist. Darjeeling (iii) Prakash Pradhan (40) s/o Lt. Madan Pradhan of Teesta Baazar, PS Kalimpong, Dist. Kalimpong and (iv) Rakesh Mandal @ Kaiya (23) s/o Lt. Raju Mandal of Green Park, Pokajote, PS Pradhan Nagar, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 33 inch (approx) including butt from the possession of Suraj Mandal @ Gholta which was kept concealed on his back side.
- (2) One iron made axe measuring 20 inch (approx) including wooden butt from the possession of Rakesh Trikhatri which was kept concealed on his back side.
- (3) One iron made sword measuring 22 inch (approx) including wooden butt from the possession of Prakash Pradhan which was kept concealed on his back side.
- (4) One iron made sword measuring 22 inch (approx) including wooden butt from the possession of Rakesh Mandal @ Kaiya which was kept concealed on his back side
- (5) Two torch light found from the place of occurrence,
- (6) One long iron measuring 26 inch (approx) in length found from the place of occurrence.

I, SI Abhishek Theengh, S/O- Suchandra Kumar Theengh of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Suraj Mandal @ Gholta, ii) Rakesh Trikhatri, iii) Prakash Pradhan and (iv) Rakesh Mandal @ Kaiya and others to the effect that today on 25.03.2022 at 23.45 hrs received a sources information that 14/ 15 youths have assembled at Lavanya Kata near Darjeeling More under Pradhan Nagar PS with a view to commit dacoity in a house at Ratanlal Busty area. The fact was diarized in GD vide Pradhan Nagar PS GDE No-1489, dated 25.03.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Ashit Singh, CV/128 Ajay Sahani, CV/223 Swapan Chettri and CV/645 Pankaj Gupta left for the place to work out the information. At about 00.05 hrs after reaching at Lavanya Kata near Darjeeling More under Pradhan Nagar PS, I met my source and being pointed by the source we started walking towards the back side of Lavanya Kata and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on a hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However, the other persons managed to fled away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Ratal Lala Busty area.



I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witness and acknowledged by the accused persons. The whole seizure was made in between 00.30 hrs. to 01.25 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and witness and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Ratanlal Busty area. It has been also revealed from them that Akash, Zabra and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz (i) Suraj Mandal @ Gholta s/o Lt. Ganesh Mandal of Mahakal Pally, near Surya Sen Park, PS Bhaktinagar, Dist. Jalpaiguri (ii) Rakesh Trikhatri (40) s/o Lt. Narjit Trikhatri of Gurung Busty near SNT, PS Pradhan Nagar, Dist. Darjeeling (iii) Prakash Pradhan (40) s/o Lt. Madan Pradhan of Teesta Baazar, PS Kalimpong, Dist. Kalimpong and (iv) Rakesh Mandal @ Kaiya (23) s/o Lt. Raju Mandal of Green Park, Pokaijote, PS Pradhan Nagar, Dist. Darjeeling, Akash, Zabra and others and arrange for its investigation.
