In producing herewith one arrested accused person namely Mastan Mardi (28), S/O - Hapna Mardi, of - Banij Jote, Neemtala, PO - Rangapani, PS - Phansidewa, Dist - Darjeeling along with one seized vehicle (Tractor with trolley) bearing registration no WB 71 B / 5886 loaded with river bed materials (Sand).

I ASI Anupam Roy of NBMC OP Under Matigara PS beg to lodge a written complaint against the driver of the above mentioned vehicle named Mastan Mardi and the owner of the vehicle bearing registration no WB 71 B / 5886, to the effect that today on 25.03.2023 at 15.55 hrs in course of evening van duty vide GDE No 626 dated 25.03.2023 I along with C/ 1085 Mithun Debnath & C/373 Bablu Barman reached at Balason River at Nimtalaghat under Matigara PS, Dist - Darjeeling and found that some persons were loading river bed materials in a Tractor with trolley bearing registration no WB 71 B / 5886 from the rivers of Balason under Darjeeling District. Seeing the police van the driver of Tractor and others are trying to fled away from the spot, but we managed to intercept the above noted vehicle and apprehended above noted person. On interrogation he disclose his name and identity as Mastan Mardi (28), S/O - Hapna Mardi, of - Banij Jote, Neemtala, PO - Rangapani, PS - Phansidewa, Dist - Darjeeling and confessed that he is the driver of above noted Tractor, he also confessed that he along with others were stealing the river bed materials (Sand) from the river of Balason at Nimtalaghat under Matigara PS, Dist - Darjeeling for selling clandestinely. On demand the above noted accused person failed to produce any document for possessing the river bed materials and he also stated that as per direction of owner of the tractor bearing registration no WB 71 B / 5886 he stolen the river bed materials (Sand) from Nimtala Ghat under Matigara PS, Dist - Darjeeling. There is sufficient reason to believe that the above noted vehicle driver have stolen river bed materials (Sand) from the river of Balason at Nimtalaghat under Matigara PS, Dist - Darjeeling for selling clandestinely. Accordingly, I seized the vehicles (Tractor with trolley) bearing registration no WB 71 B / 5886 loaded with river bed materials (Sand) under proper seizure list and arrest the above noted person U/S 41 Cr.P.C informing him the ground of arrest after issuing Memo of arrest. The search, seizure and arrest were made in between 16.45 hrs and 17.05 hrs on 25.03.2023.

Under this circumstance I pray before you a specific case against the above noted accused person namely Mastan Mardi (28), S/O - Hapna Mardi, of - Banij Jote, Neemtala, PO - Rangapani, PS - Phansidewa, Dist - Darjeeling and owner of the vehicle bearing registration no WB 71 B / 5886 may kindly be started and arrange for its investigation.
