In producing herewith one arrested accused person namely Mastan Mardi (28), 5/O – Hapna Mardi, of – Banij Jote, Neemtala, PO – Rangapani, PS – Phansidewa, Dist – Darjeeling along with one seized vehicle (Tractor with trolley) bearing registration no WB 71 B / 5886 loaded with river bed materials (Sand).

On demand the above noted accused person failed to produce any document for possessing the river bed materials and he also stated that as per direction of owner of the tractor bearing registration no WB 71 B / 5886 he stolen the river bed materials (Sand) from Nimtala Ghat under Matigara PS, Dist - Darjeeling. There is sufficient reason to believe that the above noted vehicle driver have stolen river bed materials (Sand) from the river of Balason at Nimtalaghat under Matigara PS, Dist - Darjeeling for selling clandestinely.
