**Sub:-** Written Complaint against mob attack with dangerous weapons by miscreants namely 1. Bishnu Roy, 2. Sadin Bala Roy, Wife of Bishnu Roy, 3. Sushat Roy, Son of Bishnu Roy, 4. Bamkim Roy, 5. Tapas Roy, 6. Kolin Barman, 7. Dhan Hari Roy, 8. Dhanjay Roy, 9. Nabak Kumar Roy, 10. Sita Roy Daughter of Bhola Roy, 11. Dipak Singha, 12. Shanker Roy and others with an attempt to murder and causing grievous hurt to my attorney Sri Anil Roy.

Sir,

I, Sri Dulal Chandra Ghosh, Son of Late Sukhlal Chandra Ghosh of Vidyasaga Pally, Ward No. 7 of Siliguri Municipal Corporation, Siliguri, P.S. Siliguri District- Darjeeling do hereby lodge this complaint against the miscreant: namely 1. Bishnu Roy, 2. Sadin Bala Roy, Wife of Bishnu Roy, 3. Sushat Roy Son of Bishnu Roy, 4. Bamkim Roy, 5. Tapas Roy, 6. Kolin Barman, 7. Dhan Hari Roy, 8. Dhanjay Roy, 9. Nabak Kumar Roy, 10. Sita Roy, Daughter of Bhola Roy, 11. Dipak Singha, 12. Shanker Roy and others to the effect that I am the recorded owner in possession of huge portion of land including land in L.R Plot Nos. 49, 53, 152 and 153 recorded in **L.R. Khatian No. 206** situated in Mouza - Panchkalguri, J.L. No. 59, P.S. Matigara, District - Darjeeling having purchased the same vide registered **Deed of Sale being document no. 569 for the year 1986** duly registered in the office of the Sub-Registrar at Siliguri.

I have duly nominated, constituted and appointed one Anil Roy, son of Surendra Roy, resident of Panchkalguri, P.O. New Chamta, P.S. Matigara, District - Darjeeling to look after, manage and supervise my aforesaid land by virtue of General Power of Attorney.

That since the month of February, 2023 some antisocial elements are trying to disturb my peaceful possession over the said land and I have also informed the Police Station regarding the illegal acts of the miscreants.

That yesterday i.e. 26/03/2023 at around 1pm when my said attorney Sri Anil Roy visited my aforesaid land, huge numbers of antisocial elements including 1. Bishnu Roy, 2. Sadin Bala Roy, Wife of Bishnu Roy, 3. Sushat Roy, Son of Bishnu Roy, 4. Bamkim Roy, 5. Tapas Roy, 6. Kolin Barman, 7. Dhan Hari Roy, 8. Dhanjay Roy, 9. Nabak Kumar Roy, 10. Sita Roy, Daughter of Bhola Roy, 11. Dipak Singha, 12. Shanker Roy and some others gathered in my said land and

miscreants more than 20 in numbers thereafter assaulted mercilessly Anil Roy with dangerous weapons such as bamboo stick, iron rod and kukhuri with an intent to kill the said Anil Roy. The said persons were shouting that they shall physically assault to death to the said Anil Roy and the mob was very violent and aggressive in nature which can be seen and is evident from various video footages of the spot which is in my possession.

That due to such hues and cry the police officials of Matigara Police Station reached the spot soon thereafter but the said mob was so violent and determinate with their intention of killing Anil Roy that they even did not pay any heed to the police officials and brutally attacked with boulders to said Anil Roy in presence of police officials also, the same is evident from the video footages of the incident.


Somehow the police officials managed to resist Anil Roy from hands of the said mob but till then it was too late and the said Anil Roy has suffered grievous injuries on his head, face and all over the body and was immediately admitted to Neotia Getwell Hospital at Uttorayon Township and at present the said Anil Roy is fighting between life and death and is admitted in ICU in Avalon Hospital, Lexicon More, Matigara. The said Anil Roy have suffered grievous injuries all over his body and CT Scan and other diagnosis of Anil Roy is under process.

The said miscreants had clear intention to take life of Anil Roy which is clearly evident from the fact that they even did not pay any heed to the request of police officials and brutally assaulted Anil Roy in presence of them. The intention of the said mob was to extort my aforesaid land and to give effect to their act of extortion they have committed such an illegal and unlawful offences.

In the said circumstances, it is my humble request to take appropriate action against the offending persons for the offences committed by them under Sections 307/326/329/341/447/506/34 and other relevant provisions of Indian Penal Code.
