At about 01:2 reaching near Chandmoni Ground under PS- Matigara I met my source and being the source we started walking towards Chandmoni Ground, back side of Chandmoni 01:35 hrs. we reached at Chandmoni Ground, back side of Chandmoni Temple : cordoning off the suspected persons as shown by the source with a strong reason to they were preparing to commit some cognizable offence and were about to move fro Seeing police personnel approaching towards them they tried to flee away but on h managed to apprehend above noted 04(four) accused persons along with seized mentioned above. However, the other persons managed to flee away from the spo advantage of darkness. On interrogation all the accused persons admitted the assembled there to commit dacoity in a house at Uttorayan Township area.
