Sub: Written Complaint against 01(One) Toto Driver

Respected Sir,

I A.S.I Uttam Chowdhury of Kawakhali Traffic Guard Out Post, SPC beg to lodged a written complaint that on 28/03/2023 at around 16.45 PM hrs I have received an information that 01 (one) Toto vehicle without any registered number is stationed on AH-2 near North Bengal Medical College under Matigara PS in such a way blocking the free flow of Traffic and causing hindrance to the general public and free flow of others vehicles. accordingly diaries the fact in GDE above noted and also informed to O/C, Kawakhali Traffic Guard out post under Bagdogra Traffic Guard and his direction I ASI Uttam Chowdhury along with C/683Mir Rejaul had been to the spot near NBMC & H new gate, PS-Matigara at around 16.45 hrs and found the above noted Toto vehicles along with driver had been stationed in such a manner disrupting the free flow of traffic, causing hindrance and danger to the general public and otehr playing vehicles on being asked he disclosed his name as Bapi Biswas, s/o Bhupati Biswas, Sipai Para, Dabgram, P.S NJP, Dist- Jalpaiguri.

Further on being asked him to produced relevant documents in support of his claim of playing toto and Asian Highway, but he failed to produce the same. hence he committed the cognizable offence disturbing the free flow of vehicular of traffic and endangering the life and free movement of public in general. As such I arrested him u/s 41 Cr. PC after preparing proper arrest Memo and briefing him about the ground of his arrest in proper way. Thereafter I also seized the Toto from his possession after preparing proper seizure list under 102 Cr. PC in presence of local witnesses' and duly sign by him and took into custody. Hence I would therefore request you to kindly start a specific case under proper section of law against above noted Toto driver and oblige.
