Subject: FIR

Sir,

In producing herewith one (01) arrested accused person namely Bocha Sarkar (55yrs) S/O Anil Chandra Sarkar of North Bharat Nagar. Ward No. 24, PS Siliguri Dist Darjeeling, arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (i) Four (04) Numbers of, "EXID POWERSAFE PLUS" Sealed Lead Acid Battery, having battery No. (a) 4XL032514029557, (b) 4XL062514018179, (c) 4XL032716032607, & (d) 4XL032514029552 (All types of FE04-EP65-12)
- (ii) One approx. 12 inches iron rod.

I, SI- Rajiv Subba (27yrs), S/O- Basanta Subba of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the accused person namely Bocha Sarkar (55yrs) S/O Anil Chandra Sarkar of North Bharat Nagar. Ward No. 24, PS Siliguri Dist Darjeeling to the effect that today on 28.03.2023 at 02.00hrs, while performing K-22 Night Mobile van duty I received a telephonic information from Siliguri Police Control room that one person is trying to break the State Bank of India's ATM machine installed at South Bharat Nagar, ward No. 24. PS Siliguri, Dist-Darjeeling, with a view to commit theft. Accordingly, I along with force rushed at the spot and seeing police personnel approaching towards him. He tried to flee away but on hot chase we managed to apprehend above noted accused person along with seized articles as mentioned above. On interrogation the accused person disclosed his name and address mentioned above and in further interrogation he admitted that he had made several unsuccessful attempts to break the lock of ATM machine with the help of iron rod but he did not succeed to break the lock of ATM Machine and thereafter he breaks the door of service room of said ATM and stolen four (04) Numbers of, "EXID POWERSAFE PLUS" Sealed Lead Acid Battery.

I thereafter, seized the above noted articles under proper seizure list from the exclusive possession of accused person, duly signed by the witnesses and acknowledged by the accused person. The whole seizure was made in between 02.25 hrs to 02.45 hrs. Thereafter, I arrested the above noted accused person u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused person and also supplied the copy of the memo of arrest to him. I accordingly brought the arrested accused person along with seized article at Siliguri Police Station for further investigation.

Hence, a specific case may kindly be started under proper section of Law against the accused person namely Bocha Sarkar (55yrs) S/O Anil Chandra Sarkar of North Bharat Nagar. Ward No. 24, PS Siliguri Dist Darjeeling, and arrange for its investigation.
