PS Siliguri, Dist-Darjeeling, with a view to commit theft. Accordingly, I along withforce rushed at the spot and seeing police personnel approaching towards him. He tried to flee away but on hot chase we managed to apprehend above noted accused person along with seized articles as mentioned above. On interrogation the accused person disclosed his name and address mentioned above and in further interrogation he admitted that hehad made several unsuccessful attemptsto break the lock of ATM machine with the help of iron rodbut he did not success to break the lock of ATM Machine and thereafter he breaks the door of service room of said ATM and stolenfour (04) Numbers of, "EXID POWERSAFE PLUS" Sealed Lead Acid Battery.

I thereafter, seized the above noted articles under proper seizure list from the exclusive possession of accused person, duly signed by the witnesses and acknowledged by the accused person.
