Respected Sir,

I, Seema Mishra, wife of Sri Mithlesh (Gopal) Mishra, am a resident of Mishra Mansion (UCO Bank Building), 156 Hill Cart Road, Siliguri.

I wish to report the following incidence which has been reported to me by my staff, Mr. Shankar Dey.

My husband, Sri Mithlesh Mishra has an office of his courier service at Neelkamal Plaza, Hill Cart Road, Siliguri.

Today at about 12 noon when my staff of our courier service, Sri Shankar Dey, went to open the office, he found that the entrance to the office premises alongwith the entire footpath was blocked by an ongoing bamboo construction. On raising an objection to this blockage with those who were constructing it, one Nisith Agarwal, S/o Bhimraj Agarwal, his son Sarvesh Agarwal and a few of their associates/staff came shouting at him. It Is important to mention here that Nisith Agarwal also has an office at Neelkamal Plaza. When our staff raised his objection to this blockage of way to our office with Nisith Agarwal, the entire group started hurling abuses at him and suddenly assaulted.

In the meanwhile, my husband, Mithlesh Mishra, also reached the office site and he was totally taken aback by this assault that was happening on his staff. Seeing my husband the entire group turned their towards him and started hitting my husband very badly. At this my staff, Shankar Dey, tried to protect my husband but he too was beaten badly. He was also pushed heavily by Nisith Agarwal after which Shankar fell back hitting the corner pavement of our office and was badly injured in the back.

Immediately after this my husband, MIthlesh Mishra, was also pushed and thrown on the hard ground. Sarvesh Agarwal then sat on his chest and started hitting my husband with his fists and kept hitting his face. Sarvesh Agarwal then snatched the gold chain from the neck of my husband. The rest of the group including Nisith Agarwal surrounded my husband and started hitting and kicking him with their boots with intention to kill him.

After being in this position for a while, my husband somehow got up. The blows form the entire group kept hitting him and my husband was again pushed on the cycles parked there.

During this period the mobile of my husband (bearing number 980004464 of MI company make, black color) slipped out of his pocket which was picked up by Sarvesh Agarwal in the milieu. He then handed it over to one of his staff.

Just after this some people gathered there and tried to save my husband, but Nisith Agarwal and his son Sarvesh kept hitting my husband intermittently. After much persuasion the people gathered were able to stop Nisith Agarwal and his son Sarvesh Agarwal from hitting my husband.

After some time, when my husband was returning to our home, suddenly Nisith Agarwal and his son Sarvesh Agarwal charged at my husband with bamboo from behind. My husband sensed something wrong and turned back and at that very moment he was hit on his forehead by Nisith Agarwal with the bamboo. Sarvesh Agarwal also hit my husband with bamboo on his body. As my husband fell to the ground, they ran away from the spot.

Hearing the help cry, another staff of our courier service reached the spot and picked up my husband and took him to Siliguri District Hospital where he is admitted in a serious condition. In view of the current medical condition of my husband, Mithlesh Mishra alongwith his other preexisting medical conditions including Sleep-Apnea (which requires a plug point at night) and no bed being available in the hospital and no plug-point being available near the patient, he has been referred to be taken to a better hospital.

it may also kindly be noted that Nisith Agarwal and his son Sarvesh time and again quarrel with my husband over one issue or the other and that this attack on him only seems premeditated by them. In the above circumstances I plead with you to take necessary legal action against them.
