aged about 22 years, resident of North Rabindra  
Nagar, R.S. Villa, House No. 55, Bradabbar Sarani,  
P.O. Rabindra Sarani, P.S. Silguri, Dist. Darjeeling,  
pin code: 734006, I would like to draw your  
attention regarding my matter in disputes herein  
below as follows: —

1. That I and my alleged husband, namely Sri  
Paban Das, S/o. Sri Narayan Das, resident  
of Bidyachakra colony, Ward No. 19 of S.M.C.,  
Silguri, Dist. Darjeeling, pin code: 734001,  
West Bengal, had solemnized our marriage  
on 24. 01. 2021 in accordance with Marriage  
Registration under Special Marriage Act and  
subsequently our marriage was consummated/  
solemnized in the mode of social form on  
13. 12. 2021.
2. That from the very beginning of our marriage,  
my above named husband and all members of  
only matrimonial home had / have treated  
cruelly upon me, Indeed, after coming to my  
in-laws house, I found that my father-in-law  
Sri Narayan Das was lustful, sensual and  
sexual other and tried to molest me. But

anyhow I saved my self from his such action.

3. That my mother -in-law namely Smt. Nagantara was abused me by biting and insulting language and physically assaulted me by fists and blows and by kicks of most of the days.
4. That it is mentioned here that my above named wedged husband was physically assaulted me by fists and blows and by kicks at every nights when he drunken in condition at that moment in the presence of my In-laws.
5. That even though, my Nanad (sister-in-law) namely Priyanka was also used to assault upon me with the abetment/instigate of my husband's grandmother namely Smt Kanala who, N/o. unknown and notwithstanding, younger Aunty (Chotopichi) namely Bita Bichu, was continuously torturing physically and mentally upon me during my matrimonial period.
6. That on 30.3.2023 at about 3. p.m (midnight) my husband was still drunken condition and while he return back to my matrimonial house, I was sleeping at that point of time, Henceforth, he was started to assaulted me by fists and blows and by kicks and used criminal force upon me due to I was not served dinner (his issue of demand). I fell down on the floor. Thereafter, my father In-law pushed the spot and eventually he caught my sensitive parts of my body and in such way they cut naked my modesty.

I raised hue and cry and informed my mother over telephone and my mother had

Come and saved me from their hands.

Now, I am staying in my mother house and as a matter fact while I and another were leaving from my matrimonial home then my husband told that "Terror go with Gang-戚戚 wife Prog-Gorfor (অৱশ্য গংগ-গংগ-  
বাবু প্রথ পোর তুমি". Thus they were completely deserted me from my matrimonial home on last night.

I therefore, pray before you to
