This is to inform you that I, Anupam Dalmia, have been a victim of Cyber Crime, and my phone number and both the SBI accounts which is linked with UPI Id has been hacked on $20^{th}~\&~21^{st}$ March, 2023, & total 4 (four) transactions has been made.

As the total incident took place on 20.03.23 morning when I called DTDC courier to trace my parcel from Noida which was urgent for me to get, I called the call centre number of DTDC Authorised website and the Customer Care Representative told me that my phone number is mentioned wrong on the courier parcel and need to update my number so for that I need to pay Rs. 3 through UPI Id & they sent me link of payment through which I have paid Rs. 3 after 3 unsuccessful transaction & simultaneously they are talking to me over the phone, and I feel so they have hacked my phone & 2 (two) accounts was linked with my UPI Id, and both has debited with unknown name, as I found all narration is similar. The message from SBI for the amount debited (RS. 87,750.96/-) from my 2 SBI accounts was received by me on my phone on 21.03.23.

Please look into the matter as on urgent.
