Pradhan Nagar Police Station I, TARKESHWAR SHAW, SON OF SHIWLAL SHAW, ura milicon permanent resident of Natunpara, Ganga Nagar, Near Jalpai More, Post Office Siliguri Bazar, Police Station Siliguri, District Darjeeling. I am a businessman and my businesses are operated from aforesaid place and from Champasari, behind Circuit House, under Post office and police Station Pradhan Nagar, District Darjeeling. I am a law abiding and peace loving person.

1. Mr. Manoj Singh; Son of Lakhi Singh, 2. Mr. Suman Das; Son of Sapan Das, 3. Mr. Puchki Mahato; Son of Subodh Mahato, all residents of Devidanga, under Police Station Pradhan Nagar, District Darjeeling, alongwith their associates have approached me in the month of January, 2023 to sell the below schedule described land measuring 3 (three) Katha, hereinafter for the sake of brevity referred to as "the land". Abovenamed Mr. Manoj Singh has initially falsely represented and personated himself as owner of the land. I when pressed for the legal documents of the land, they reveal that one Mr. Suraj Chhetri, Son of Chandra Prasad Chhetri, resident of 'Gupta Building', Upper Bhanu Nagar, Ward No.43, Police Station Bhaktinagar, District Jalpaiguri, is the actual owner of the land and they are being authorised by the abovenamed owner of the land to sell the land. I believing upon their words agreed to purchase the land and an Agreement for Sale was executed on 23<sup>rd</sup> January, 2023. They have taken Rs.4,00,000/- (Rupees Four Lac) only from me as baina/ advance for the sale of the land. I have good and valid receipt thereof with me. They have further taken Rs.1,70,000/- (Rupees One Lac Seventy Thousand) only from me to construct a boundary wall fencing the land.

While fencing the land, another person appeared acclaiming to be the owner of the land. Being aware of the incident, I called upon abovenamed persons namely, Mr. Manoj Singh, Mr. Puchki Mahato and Mr. Suman Das and raised my apprehensions. They have however settled the issues with said persons and persuaded and convince me that aforesaid Suraj Chhetri having absolute ownership over the land. I being alarmed published NOTICE in two vernaculars Newspaper, asking claims from stake holders of the land, if any, to clear the matters. I thereafter several times asked Mr. Manoj Singh to provide me EPIC, AADHAAR Card, PAN Card and Bank details of Mr. Suraj Chhetri. They have reluctantly given me bank account of Mr. Suraj Chhetri, recently opened in I C I C I Bank, Shivmandir Branch and fails to provide me EPIC and PAN Card of Mr. Suraj Chhetri.

I have raised my concerns and upon discussions they have refused to give me either registration of the land and further denied to return the advance amount of Rs4,00,000/- (Rupees Four Lac) only alongwith Rs.1,70,000/- (Rupees One Lac Seventy Thousand) only taken by them for constructing boundary over the land. They have also threatened me with dire consequences and have threatened me of my life and limbs, if I pressed for registration of the land and return of my aforesaid payments.

Sir, I come to know that Mr. Manoj Singh, Mr. Puchki Mahato and Mr. Suman Dash are land mafias and Mr. Manoj Singh was also apprehended by Siliguri Police Commissionerate in its recent drive against the land mafias of the locality.

I, therefore, request you to take immediate action against these land mafias, namely Mr. Manoj Singh, Mr. Puchki Mahato and Mr. Suman Das and their associates and do justice to me.

I shall be grateful to you for this kind act.
