Sir,

In producing herewith one accused person named Mitilesh Kumar Pandit (M/33 years) S/O Sri Surendra Pandit of Dalsingh Sarai, PS Dalsingh Sarai, Dist. Samistipur, Bihar under arrest along with following articles under proper seizure.

1. Forty-Eight (48) bottles of Himalayan Bear Indian Whisky, each bottle containing 375 ML, MRP Rs. 100/- each, seized from the possession of Mitilesh Kumar Pandit.

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person namely Mitilesh Kumar Pandit (M/33 years) S/O Sri Surendra Pandit of Dalsingh Sarai, PS Dalsingh Sarai, Dist. Samistipur, Bihar to the effect that today on 04.04.2023 at 21.15 hrs. received a source information that one person has been standing at Siliguri Junction under Pradhan Nagar PS with huge quantity of illicit liquor without any valid license.

Accordingly, I informed the matter to your good notice and as per your kind direction I along with ASI ASI Ashit Singh, CV/646 Baban Das, CV/242 Rakesh Mangar had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was standing at Siliguri Junction with huge quantity of illicit liquor. Subsequently, I along with my force cordoned the spot and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as mentioned above.

Further being searched the above noted seized articles were found from his possession. On demand he failed to produce any valid license/papers for the articles which was recovered from his possession. On further interrogation he stated that he was involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal illicit liquors under proper seizure list in presence of witness and arrested the above-mentioned person named Mitilesh Kumar Pandit (M/33 years) S/O Sri Surendra Pandit of Dalsingh Sarai, PS Dalsingh Sarai, Dist. Samistipur, Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21.30 hrs to 22.15 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Mitilesh Kumar Pandit (M/33 years) S/O Sri Surendra Pandit of Dalsingh Sarai, PS Dalsingh Sarai, Dist. Samistipur, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
