beg to inform you that on St. 19.03.2023 at about
08:00 pm, when I returned home from Dalkhola, at
Tumelpara, where my father namely, Sri Rajkumar
Mahato (47) S/o Lt. Bachelor Mahato, was alone at
my house at Tumelpara, Ward No. 4, P.S. Siliguri and
found that the door of my house was opened
and my said father was lying at floor inside the
room in unconscious condition, I thought that due
to Diabetes, he became unconscious and in the
next morning, I went to my work and when my
mother & other family members return home they took
care of him, but when no development was found in
his condition then we admitted him to Prayag
Niketan Nursing home on St. 25.03.2023 and shifted
him to Pulse Hospital, Prapilla Nagar, Behind Cine
house, Champasari, Siliguri for on St. 29.03.2023 and
he got operated there on said date since concerned
doctors said that he has severe heart on his
head due to hitting by some heavy article. At
present my said father is in ICU in pulse hospital
after his head operation and later on shifted to cabin
and due to his severe condition he is unable to
say about the incident presently.

Sir, me & my family members have doubt
that he has received severe internal head injury
by hitting by some heavy article used as weapon.
So, please take necessary action against those
unknown persons
