- ① That on 5th of August, 2022 I visited Concettency office namely Dream land Job and Education for the Overseas Employment to go France Country.
- ② That The Conseltant/stake holder of that Concettency namely Baishnavi Khawas, D/o Ram chandra Khawas (8145483090) Residence of Vinayak Apartment / flat No - D/1 first floor, Pradhan Nagar, Dist Darjeeling, 734003.
- ③ That the Conseltant/stake holder of that Concettency Suman Khawas, S/o Bhuvan Singh Khawas (7076038857) Residence of Mangarjung Tea Estate, Bawn Gaon, Mirik Dist. Darjeeling.
- ④ They had asked me to pay total Amount of Rs. 6,00,000/- (Six lakh only) for the Job as an Security Guard in France Country.
- ⑤ I Gave Them total Amount of Rs - 3,60,000/- (Three Lakh sixty thousand only) 60% of 6,00,000/-

④ That stake holder told me first they will send Azerbaijan Country and after 5-6 month they told us they will send us France Country.

⑤ In 6th November 2022, I fly from Bagdogra Airport to Delhi Indiragandhi Airport.

Then they took us hotel in Mahipalpur in Delhi. From Delhi Airport they can't fly me for Azerbaijan because of Document Case. Then after Again that agent told us they have their another Agent in Dubai then they send me to dubai. After 3 days they arrange for ticket to azerbaijan but same document Problem happens in Dubai International Airport. then we came from Airport and after 10 days again Agent Arrange Ticket to azerbaijan but that time they changed Airport to Sharjah Airport. They provide fake boarding pass then Airport staff caught me and I can't able to fly. I have faced lots of Problem in Airport for 5 days. Then I arrange money from our Residence we took next return flight to India. on December 2022.

Then on 5/12/22 I went to office in Seleguri for Regond the said money that time they told us they need 2 month for Regond. ~~we~~ I waited till two month After completed of 2 month. I visited office but that office was permanently shut down and that Agent was abscond, After that we visited in his Residence Seleguri Vinayak Apartment Pradhani Nagar, Flat No. D1, first floor, where we couldn't find them but we find their mother & father of Beishnavi Khawar at her Residence and that Accused mother told us they left Seleguri, and they stayed to Nepal.
