Sub: Request to file an FIR against Sri Ashish Malakar and Sri Sandip Malakar and others for forcefully trying to encroach Govt. Land within Principal market Yard, Mallaguri, Siliguri and threatening, heckling and verbally abusing the undersigned and the security officials of this office.

Sir,

I am to inform you that on 18.04.2023, Sri Ashish Malakar, Netaji Nagar, Champasari, Siliguri tried to encroach a piece and parcel of land within the Principal Market Yard under Siliguri RMC by erecting metal sheet boundary wall. Being informed, the security personnel of this office dismantled the said boundary wall at that instant. Thereafter, the said Sri Malakar alongwith 3 (three) other persons forcefully entered the office of the undersigned in the evening on the same day and threatened the security in-charge of this office, namely, Sri Swarupananda Roy.

Further, today, i.e., on 19.04.2023, Sri Malakar again tried to encroach the same piece of land by erecting metal sheet boundary wall. The undersigned alongwith security personnel and office staff went to the spot to dismantle the unauthorized erection. At that time, the said Sri Ashish Malakar and his brother Sandip Malakar alongwith other unknown miscreants heckled and verbally abused the undersigned and obstructed me from doing Government Duty and also besieged me for quite a long time. Thereafter, with the assistance of the Pradhannagar Police Officials, I could return to my office.

You are, therefore, requested to lodge an FIR against the said Sri Ashish Malakar and Sri Sandip Malakar and other unknown miscreants and take necessary action accordingly for attempting to encroach Government Land unauthorizedly and other misdeeds as mentioned above.

An early action in this regard is requested.
