Sir,

In producing herewith three (03) arrested accused persons namely (i) Suraj Chettri (23), S/O- Lt. Sasti Chettri of Gas Godown, PS Matigara, Dist. Darjeeling (ii) Suraj Barman (19) s/o Radha Chandra Barman of Shiv Nagar Colony, PS Matigara, Dist. Darjeeling (iii) Khokan Mahanto (25) s/o Lt. Bablu Mohanto of Utpal Nagar, PS Pradhan Nagar, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 33 inch (approx) including butt from the possession of Suraj Chettri which was kept concealed on his back side.
- (2) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Suraj Barman which was kept concealed on his back side.
- (3) One iron made sword measuring 22 inch (approx) including wooden butt from the possession of Khokan Mahanto which was kept concealed on his back side.
- (4) Three torch light found from the place of occurrence,

I, SI Abhishek Theengh, S/O- Suchandra Kumar Theengh of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Suraj Chettri, ii) Suraj Barman, iii) Khokan Mahanto and others to the effect that today on 19.04.2023 at 23.30 hrs received a sources information that 13/15 youths have assembled below Mahananda bridge under Pradhan Nagar PS with a view to commit dacoity in a house at Gurung busty bazaar area. The fact was diarized in GD vide Pradhan Nagar PS GDE No-1102, dated 19.04.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with CV/242 Rakesh Mangar, CV/992 Jagadish Biswas and CV/646 Baban Das left for the place to work out the information. At about 12.05 hrs after reaching below Mahananda bridge under PS- Pradhan Nagar, I met my source and being pointed by the source we started walking towards back side of the bridge and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on a hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However, the other persons managed to fled away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Gurung Busty bazaar area.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 12.20 hrs to 12.50 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Gurung Busty bazaar area. It has been also revealed from them that Rahul @ Daku, Guddu and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz (i) Suraj Chettri (23), S/O- Lt. Sasti Chettri of Gas Godown, PS Matigara, Dist. Darjeeling (ii) Suraj Barman (19) s/o Radha Chandra Barman of Shiv Nagar Colony, PS Matigara, Dist. Darjeeling (iii) Khokan Mahanto (25) s/o Lt. Bablu Mohanto of Utpal Nagar, PS Pradhan Nagar, Dist. Darjeeling and others and arrange for its investigation.
