That on causing searching of title Deeds in the office of the A.D.S.R Siliguri-II, Bagdogra I have come across 5 (Five) purported fabricated, false and forged registered Deeds of Sale being nos. 8668, 8673,8676,8677 & 8678 all for the year 2012 registered in the office of the A.D.S.R Siliguri-II, Bagdogra executed by GALAXY REALTORS PRIVATE LIMITED, a Private Limited Company registered under the Companies Act, 1956 having registered office at - Punjabi Para, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, represented by its Director, SRI OMPRAKASH AGARWAL, son of Late Puran Chand Agarwal in favor of LIBERTY SUPPLIERS PRIVATE LIMITED, wherein it is shown as the purchaser represented by one of its Director SRI SUMIT AGARWAL, son of Sri Babulal Agarwal. In the said Deeds it is shown that LIBERTY SUPPLIERS PRIVATE LIMITED has purchased 1.32 Acres of land in L.R Plot Nos. 601 & 602 unlawfully tracing title to my purchases but out of which I have not sold 0.54 Acres of land. My unsold land has been made a part of the total land transferred by the said registered Deeds with malafide intention of cheating me and causing monetory loss to me and by recording my unsold land in their name in an unlawful manner they have intended to show that I have parted possession of my land to them.
